MANAGEMENT LETTER

Board of Directors Amigos Together For Kids, Inc. Miami, Florida

In planning and performing our audit of the financial statements of Amigos Together For Kids, Inc. Our firm's policy requires us to inform you of any <u>management points</u> discovered during our audit.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct misstatements on a timely basis. A material weakness is a deficiency, or combination of deficiencies, in internal control, such that there is a reasonable possibility that a material misstatement of the entity's financial statements will not be prevented, or detected and corrected on a timely basis.

A *management point* is an observation and/or a suggestion regarding the organization's activities that go beyond internal control related matters.
