PRIVACY STATEMENT FOR PUMP AND ABRASION TECHNOLOGIES (PTY) LTD (herein referred to as the "Company")

- Below you will find information concerning visits to and the use of the company's websites.

- This information is required in order for us to process and fulfil your request/order and otherwise provide you with the information and services you may request from us (e.g. rate changes of your order, cancellation of your order etc.).
- This information will therefore be kept by us as long as is necessary for us to use your information as described 6.1.6. above or to comply with our legal obligations (including fraud prevention, anti-money laundering and sanctions screening).
- 6.1.7. For security reasons we also keep the IP address used when the order is registered.
- Personal information collected on the Companies sites and services may, in compliance with applicable laws and regulations, be stored and processed in any country in which the Company and its subsidiaries maintain facilities.











6.2. Security of Your Personal Information

- 6.2.1. The Company has a number of security measures in place to protect your personal information.
