Lakeview Cemetery has been caring for families since 1879. The Sarnia Cemetery Company was incorporated in 1879 under the provisions of the Cemetery Act of 1877 to operate a non-denominational cemetery for the (then) Town of Sarnia. The mayor, Reeve, Sheriff, County Registrar, school inspector, doctors and other leading citizens were some of the original shareholders. After the property of Lakeview was secured, the town council passed a by-law prohibiting any more burials within the town limits and the church cemeteries ceased to function. At that time the existing church burials were removed and relocated to Lakeview Cemetery.

Today we are governed by a volunteer Board of Directors. Daily operations are administrated by a General Manager, two Client Services Advisors, along with an operations team consisting of full and part-time crematorium and grounds staff.

At Lakeview we believe families want a single point of care when a love one dies. To fulfill the wishes of our families we are now Lakeview Cemetery Burial & Cremation Services and carry the license of a Class 1 Funeral Establishment granted by the Bereavement Authority of Ontario. This means from the first call to final disposition we can guide you through all aspects of direct burial or cremation. We are here for you 24 hours a day to help you through the complexities that arise when a death occurs. We are dedicated to providing all families with options that are meaningful, appropriate and affordable. Call and speak to our funeral service providers with any questions you might have.

Urns and Jewelry

All cremated remains are returned in a labelled temporary plastic urn. This can be interred as is. You are welcome to supply your own or if you wish to purchase an urn, below is a selection. **Companion urns** are sized to fit two sets of cremated remains typically 400in³. **Keepsake urns (KS)** are designed to hold just a small amount of about three tablespoons. We will transfer cremated remains to the urn or jewelry of your choice at no charge. Below is a selection and more are found in our arrangement office.

Cemetery By-Law 30: In the best interest of the health and safety of our staff and the proper maintenance of the cemetery it is strongly recommended by the Company that all casket interments shall be enclosed in an outer container (vault) made of concrete or steel.

Explanation of Services & Glossary of Terms

Professional Services Consultation with a licensed Funeral Director to gather statistics/service Information related to the specific needs of the family. All ordering of products and services as well as administration tasks specific to the family's request **\$425**

Legal Documentation The preparation of necessary municipal documents required for a burial or cremation to occur. These include death registration, burial permit, coroner's certificate and the creation of Funeral Director Proof of Death Certificates **\$275**

Transfer of body to Lakeview Professional staff and equipment required for the local transfer of the body from the place of death within Lambton County into our care at Lakeview. An additional rate of **\$2.00/km** may be charged for transfers beyond Lambton County **\$220**

Body Care & Casketing-Basic Removal of pacemaker (for cremation only) and other medical implements, pumps & patches, jewellery, and placement in casket and refrigeration. Family will be asked to identify the deceased **\$150**

Body Care & Casketing-Viewing or Burial In addition to basic care, this also includes the bathing, shaving and dressing, and the setting of facial features for viewing without embalming **\$275**

Facility for Holding A private and secure room that is used for the shelter and preparation of the body until service time or date of disposition. Includes refrigeration facilities **\$195**

Vehicle-Utility The vehicle used for transfers, picking up and filing documents and in the case of direct burial, transporting the casketed body to graveside at Lakeview Cemetery **\$140**

Witness Cremation Family can witness the casket entering the cremation enclosure at the start of the cremation from within the arrangement office. Subject to specific times of the day. 15 minute maximum time limit **\$100.00**

Cremation Container A basic casket with wooden base and fluteboard covering. The Jutzi #25 container is for standard cases up to 250lbs. Some cases may require an oversized container. A Director can advise you at the arrangement meeting. **\$170/\$210**

Disbursements Payments made by Lakeview on behalf of the purchaser of funeral services or supplies, or both. Typical examples are the coroner's fee (\$75) death registration (\$25), Lakeview cremation fee (\$536.75) and Lakeview interment fees: Cremation (\$791.00) or full casket (\$1638.50). The application of disbursements will depend on each family's unique circumstances.

Interment Rights refer to the right to bury human remains in a grave. If you are named on the interment right's certificate you are the interment rights holder (IRH) and may request a burial or disinterment or place a decoration, marker, monument or inscription on the monument as long as you follow cemetery by-laws. If you are not the IRH you will need the permission of the IRH or their descendants to use their grave and place a marker in accordance with cemetery by-laws.

Lakeview Cemetery Interment Fee The cost to open & close the grave, niche or crypt for interment for standard adult. Also known as opening/closing fee (\$559.35-\$1695.0)

Refundable Deposit for Cremated Remains-Provincial regulation allows for the provider to charge a \$350 deposit for the interment of unclaimed cremated remains after 1 year. **\$350**

Coroner's Fee In Ontario a Coroner's Certificate to Cremate is required before a cremation can take place. The fee is set by the Coroner Office of Ontario and is paid directly to the approving medical professional. There is no HST on this disbursement (**\$75**)

Death Registration The fee charged by the City of Sarnia to register a death. There is no HST on this disbursement (**\$25**)

Recipient The person for whom the funeral services or supplies or both are to be provided under a contract or prepaid contract
