Trust account holdings are self-directed and not managed by EPTC. EPTC requires specific written directions regarding changes to any trust asset holding. These requests include, but are not limited to, (i) changing a trust asset holding, (ii) asset reallocation, or (iii) rebalancing. In each case, you must submit written directions to EPTC.

- i. New account openings do not incur the THSR fee.
- ii. Trust funding additions do not incur the THSR fee.
- iii. Distribution requests do not incur the THSR fee



- iv. No automatic rebalances available.
- v. No automatic/recurring distributions requests accepted.
