The **Thanksgiving Sherman Giveaway** (the "Giveaway") starts on **Wednesday, November 23, 2022 at 12:00 PM EST** and ends on **Friday, November 25, 2022 at 11:59pm EST**. (the "Giveaway Period").

**ELIGIBILITY:** The Giveaway is open to NFL ALL DAY users (defined as a person who created an account at [www.nflallday.com](http://www.nflallday.com) on or before November 25, 2022, and who has a valid email address associated with that account), and who are eighteen (18) years of age or older (or of the legal age of majority in their state or province of residence, whichever is older) at the time of entry. Employees of Dapper Labs Inc. ("Sponsor", "we", or "us"), the NFL Entities (as defined below), the National Football League Players Association and their respective parents, subsidiaries, affiliates, promotion and advertising agencies, and members of their immediate families (spouse and parent, children and siblings and their respective spouses, regardless of where they reside) and persons living in the same household, whether or not related, of such employees, are not eligible to win.
