

# FY2020 Annual Report

### FY2020 Major Notes and Highlights

- The corporation entered the pandemic in excellent financial position.
  - \$40k in grants in Q1
- The beginning of the pandemic was also surprisingly strong financially
  - Converted spring fundraiser from in-person to online-only event in just one month; "We Are The Medicine Festival" raised \$13k
  - o Federal EIDL loan for \$87k 30 year term, 2.75% interest, 1 year deferral
- The board decided in June to leverage our substantial cash reserves to grow rapidly.
  - Hired our first 4 W-2 employees in Q3: dedicated program and development staff
  - Executive Director Jennifer Nicolaisen freed to focus on strategic plan for growth
- New program initiatives in FY2020:
  - COVIDConnect: investments in herbal first aid and technology for online connection practice meetings while North Carolina was under stay-at-home order
  - Connection Missions: Novel non-hierarchical program for matching community needs with community service opportunities
  - Listening Line: Telephone line staffed by the community for all-day authentic connection opportunities
  - Outreach to communities of color: Launched incredibly popular connection practice circles at Haywood Street Congregation and Pisgah View Apartments
- The year ended strong with our second online festival "One Big Table", featuring internationally acclaimed speakers, including Dr. Gabor Mate, Dimitri Mugianis, Kenya Stevens, and Sara Ness.
