


# Offerings Guide

#### **OVFRVIFW**

#### INVESTMENT

The Standard Consultation includes: (1) a full file review and memo for one OWCP claim, (2) a one-hour video session and presentation, (3) all presentation materials, and (4) reference materials.



# Legal Representation Services

TO HELP YOU TAKE ACTION AND FIGHT FOR YOUR RIGHTS

#### **OVFRVIFW**

We offer legal representation services to provide direct legal intervention on a claim. As a representative we file appeals, formal requests, and applicable paperwork on your behalf. Every client has different needs.

#### INVESTMENT

#### **OWCP FECA Representation**

There are no attorney's fees under the FECA. We require a pre-payment of \$3,500 equivalent to 10 hours of work, which is the average total for most claims. Work may exceed the pre-payment, but unused hours would be refunded to you. We offer 4-month or 2-month payment plans.

#### **OWCP FECA Third-Party Representation**

We can assist with a connected third-party personal injury claim to your OWCP FECA claim. Work on the separate third-party claim itself is paid on contingency. No money is due upfront for the third-party claim.

#### Federal Disability Retirement Representation

We require a flat fee total of \$3,500. The first \$1,750 payment is due immediately. The second \$1,750 payment is due upon approval.

#### **SSDI** Representation


The SSA will pay attorney's fees capped at a maximum set by law as calculated from any past due benefits. No money is due upfront.
