In 2017, donors contributed \$958,079 to many of the more than 90 charitable funds we oversee. Our assets under management grew to \$19 million, and we distributed \$1.2 million in grants and scholarships this year.

As we reflect on our collective service to the South Puget Sound's communities throughout 2017, we are grateful for the time, talents, and resources of donors and community members that inspire philanthropy in Thurston, Mason, and Lewis. Here are just a few of our 2017 accomplishments:

- Through our new online giving initiative, Give Local South Puget Sound, we helped local nonprofits raise \$164,560.
- A \$25,000 grant to Rural Development Initiatives helped to launch the first cohort of the Mason County Rural Community Leadership program.
- We continued our work as a grantee of the Bill & Melinda Gates Foundation to address poverty in our region.


## **Moving Philanthropy Forward**

#### **ASSETS GROWTH OVER TIME**




