The rateable values of film studios saw huge increases (as much as 5x in some instances) in the 2023 revaluation of business rates that came into force on 1 April 2023. # UK Government Proposes Council Tax Exemptions For Landlords With Vacant Properties

This article looks at a UK Government consultation on a proposal to exclude landlords from paying council tax premiums on unoccupied properties whilst preparing them for tenancy or seeking new tenants, and additionally to introduce a second homes premium, dependent on whether the home is actively being marketed for rent. # Out of Home Advertising: Unlocking Investment in Infrastructure

This article calls for an exemption from business rates for advertising rights on social infrastructure such as bus shelters, telephone boxes etc. The industry cites the help it provides to local authorities by investing in social infrastructure and also providing emission reducing extras such as air quality sensors, solar panels and living roofs. The article also looks at other community projects such as installation of voice activation for the visually impaired and defibrillators. It concludes by considering the money foregone in terms of inspections, referencing, valuing, billing and rates collection for each individual site of which there are approximately 36,000 across the UK.

#### Property taxes mean it's not so easy for buildings to be green

The built environment is responsible for two fifths of carbon dioxide emissions. # Second home council tax rise could 'decimate' rural businesses, Welsh local authorities warn

In a bid to return empty second homes to the housing stock, Denbighshire County Council is proposing to increase council tax on second homes to 150% from April 2025. This article hears opposition from local farmers who have been encouraged to diversify and convert outbuildings into holiday accommodation, as this measure follows the Welsh government's change to require holiday lets to be occupied for at least 182 days of the year, up from the previous threshold of 70 days last year.
