### Four reforms to stop English councils from going bankrupt

This article provides opinion on the crisis facing local government funding, indicating that six councils have announced their bankruptcy since 2020 and others may be following unless a £4 bn gap in funding is met. The article goes on to suggest four reforms that could be made by the government to address the problem. These are: the council's require financial needs assessment, as in other European countries, and a fair funding review; there should be equitable funding to and also between councils; a standing committee should be formed to handle financial enquiries for councils and also raising issues; and a percentage of national taxes should be assigned to councils.

## Executive risks fresh stand-off with UK Government after making decision on regional rate rise

The UK government has demanded that the NI Executive must raise £113m in revenue in the next 12 months as a pre-condition for a £3.3bn package to support the restored devolved government. This article looks at the Executive's decision to increase the regional element of rates bills by only 4%, in line with inflation, despite this increase only raising £30m out of the extra £113m in extra revenue required. The increase must be approved by the Assembly, and the remainder of the article looks at the views of ministers and economists and ratepayer representatives.
