England's parishes and towns raise council tax surcharge to fund scrapped local services

This article examines the claims that a new tier of local government – parish and town councils – have been left to carry out several services normally the domain of the Local Authority. The article gives examples of how these smaller, local councils are increasingly relied upon to provide, for example, street cleaning and managing public toilets. The article explains that the 'precept' for these councils is not subject to the Local Authority cap at 5% and they can therefore increase their funding to a greater extent.

Levelling Down: Northeast to pay £420 more in council tax than Greater London

A study by the Chartered Institute of Public Finance and Accountancy (CIPFA) has shown that the Band D council taxpayers in the North-East of England pay on average £420 more than those in Greater London even though there is a vast differential in the capital values of the properties. This article looks at the reasons for the differences, including the increasing costs of adult social care for local authorities.

Larne businesses urge minister to order major audit of council's finances after rates hike

Rates in Mid and East Antrim Borough Council are set to rise by 12% for non-domestic properties and 9.78% for domestic properties for 2024/25.
