Catering

Cow Hollow Catering Company serves food and beverages in the theatre lobby when the box office opens to the public and during intermissions, if applicable. Backstage hospitality is also available as are catering services for receptions. Alcohol sale and service is available through Cow Hollow Catering. Licensees may not sell or distribute alcohol to the general public.

Security

The Palace of Fine Arts Theatre, at its sole discretion, shall determine the security needs for Licensee's engagement. At minimum, the Licensee shall be responsible for providing security at the stage door during the times and dates specified above for the engagement.

Deposit and License Agreement

A non-refundable deposit made out the **Palace of Fine Arts League** is required to confirm a date. Upon acceptance of the application and receipt of the deposit, the application will be incorporated into a License Agreement as **Addendum A**. Licensee must agree to the terms and conditions of a fully executed Agreement prior to the start of the engagement.
