Dear Kids Kare Parents: WELCOME!

A few notes for families new to Kids Kare!

CHANGE OF CLOTHES: For younger students, please have a change of clothes in their backpack in case of an accident. We allow bathroom breaks at any time but often children don't want to break away from their activities and bathroom accidents can happen. We want to always have your child comfortable and quick changes when necessary can achieve that!

Also, any student can change from their uniform to (school appropriate) play clothes.

Snacks: We break for snack around 3:45 – 4:00 each day and provide a small snack along with water. If you wish to send an additional snack for your child you are welcome to do so.

Dismissal: When you arrive at St. Christopher's to pick up your child, you need only to text or call the Kids Kare cell phone #716-364-5794. We will have your child gather his/her belongings and bring them to the Link door along with the sign-out sheet. Please — especially in the beginning of the school year, bring your driver's license with you for identification purposes until all Kids Kare staff recognize you!

Parents – if your child is returning to Kids Kare and you have previously filled out and returned a Kids Kare registration form, you only need to resubmit IF THERE ARE ANY CHANGES TO PHONE CONTACT NUMBERS, PERSONS ALLOWED TO (OR NOT ALLOWED) TO PICK UP YOUR CHILD(REN) – OR ANY PERTINENT INFORMATION YOU WISH TO HAVE ON RECORD.

Participation Guidelines & Payment Information

- Registration Form must be on file prior to the first day of attendance.
 Please send this form to the school office attention: Kids Kare ~ ASAP.
- Calendars that request participation in Kids Kare for your child are located on the website monthly. Please fill out a calendar each month indicating the days you anticipate your child/ren would need to attend Kids Kare so adequate staffing can be achieved.
- 3. ALL KIDS KARE PAYMENTS MUST BE CURRENT IN ORDER TO MAINTAIN ENROLLMENT IN THE PROGRAM.

If the balance is NOT current the following measures will be implemented:

- 1. Parent is responsible for contacting the school bookkeeper, Shari Ingraham @ 692-2660 x329 for any questions concerning payments or to make arrangements, including for end-of-year statements.
- If payment arrangements are not met, families agree to reimburse
 Christopher School for fees from any collection agency, which may be based on a percentage at a maximum of 33% of the debt and all costs and expenses, including reasonable attorney's fees occurring in such collection efforts.
- 3. The child/ren will not attend Kids Kare until the balance has been remitted. Re-registration in subsequent years in the Kids Kare Program may be jeopardized and will require a conference with administration for the child/ren to be reinstated.
- 4. I also understand if funds are not available for withdrawal, a \$25 insufficient Funds Fee will be incurred. This fee also applies to checks that have bounced.
