- 1.1 Hull College Further Education Corporation is responsible for the delivery of Apprenticeships, Employability training and alternative funding contracts including European Social Fund and Department for Work and Pensions.
- **1.2** Hull College is currently out to procure for suitable organisations that can support us with the delivery of Adult Education Budget learning provision.
- **1.3** We are looking to procure organisations to deliver on a set of dedicated deliverables to respond to emerging skills issues through the delivery of training; supporting innovation; responsive delivery in the Hull and Humber region, which align to the Humber Local Enterprise Partnership's employment and skills strategy.

Section 2: Service Requirements

- **2.1** Using Adult Education Budget allocated funding, within the Hull and Humber areas we are looking to increase our subcontracted training provision.
- **2.2**The scope for delivery is to support Hull College with meeting local and regional skills gaps outside of Hull College's current capacity and/or capability.
- **2.3** Funding will be subject to a 20% management fee and a 10% retention fee, the retention fee will be paid back on the condition that all Key Performance Indicators have been met/achieved by the end of the contractual year.

Section 3: Geographical Requirement

- **3.1** The Humber LEP covers four local authorities:
 - Hull
 - East Riding
 - North Lincolnshire
 - North East Lincolnshire

Section 4: Contract Value and Duration

4.1 Note: No volumes or funding allocations can be guaranteed. The maximum contract value, should you be successful will be agreed with you as part of the negotiation and on-boarding process.

- **4.2** The duration of the sub-contracted delivery will be from January 2022 and terminate on the 31st July 2022
- **4.3** Contract Deliverables KPIs will be agreed with you as part of the negotiation and on-boarding process.

Section 5: Payment Model

5.1 Payments are made in line with the ESFA payment to the College, all payments are validated through a monthly ILR return, any payments not processed as part of the ILR return will be made the following month. Payments are made the last working day of the month

Section 6: Security Requirements

6.1 Hull College requires all delivery partners to have a GDPR/Data Protection Policy in place and will require partners to be able to demonstrate that reasonable measures are in place to securely process and store learner and employer data.

Section 7: Evaluation Criteria

- **7.1** Exclusion Criteria: any organisation answering no to these questions will be automatically excluded from the project.
- 7.2. Scoring Where the question is scored out of 1 on the PQQ, these questions have to be met to be continued to be considered for scoring.

All other questions within the PQQ are scored on a scale of 1-10. Any organisations scoring 2 or below on a question may be excluded from the process.
