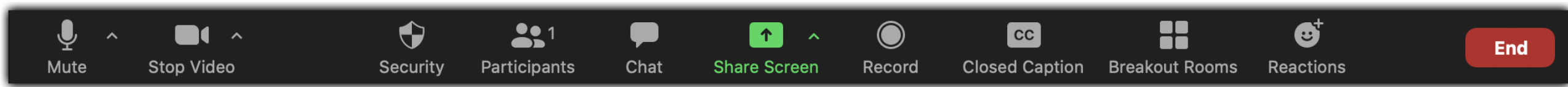

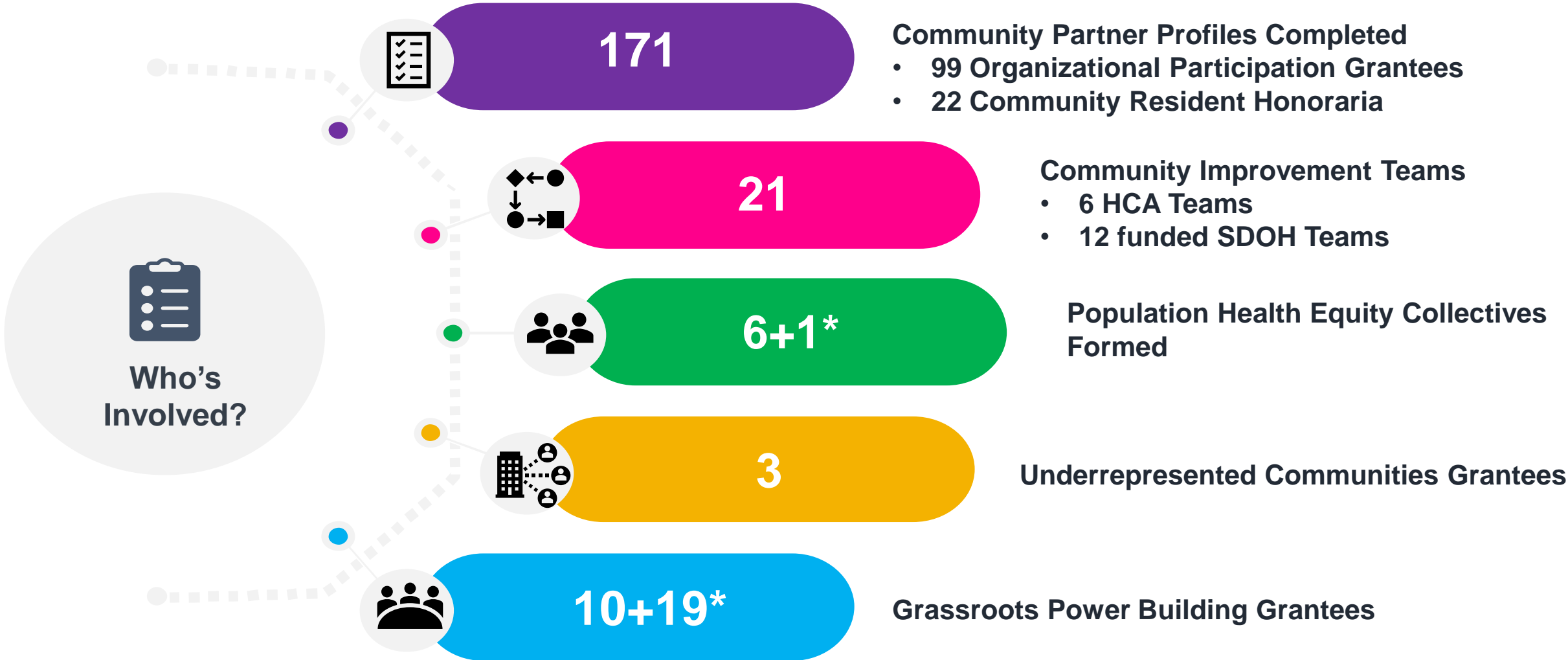
In these ways...

- **OPHE Self-assessments assess internal policy & practices**
- **HCA Equity Improvement Team builds population health equity capacity & infrastructure**
- **EiOC Taskforce conducts data-driven community planning & engagement**
- **Community Honoraria engage residents in process (\$220K)**
- **Organizational Participation grants support engagement in process (\$2M)**
- **Services provided to Underrepresented Communities (Transgender & Gender Nonconforming, Native American and API) (\$1.08M)**
- **3SDoH Funded Action Areas: Food as Medicine, Housing is Health & Health & Healing (\$6M)**
- **Power Building Fund (10+ grantees) who attend Community Health Improvement Leadership Academy and get funds to build capacity (\$1.5M)**
- **6 Populations Health Collectives (API, African American/Black, Individuals w/Disabilities, Latinx, LGBTQ+, Older Adults) create HEP and expand capacity to support priority populations (\$2.4M)**

Who's Involved in EiOC?



UNDERREPRESENTED COMMUNITIES' GRANTEES (Year 2 began May 1st)

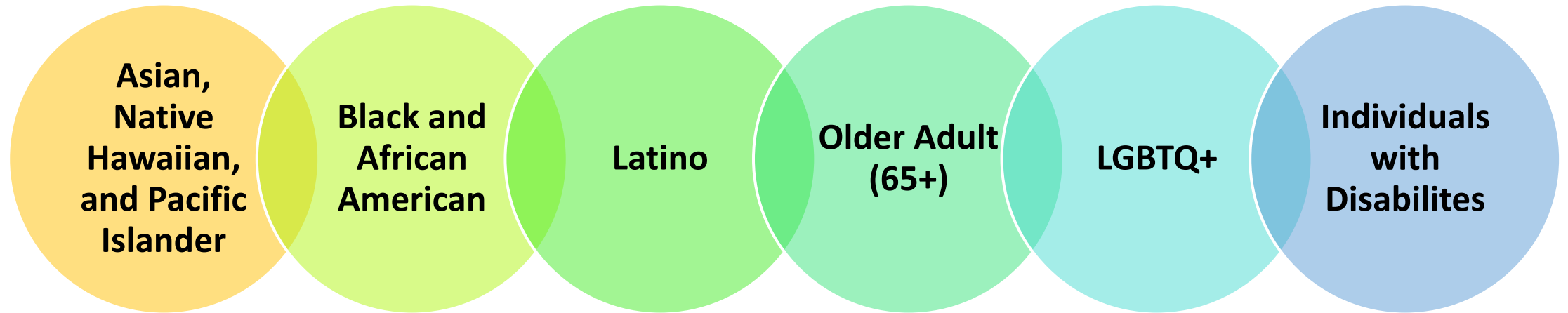
- **Underserved/Underrepresented Communities Grantees** (*Native Hawaiians and Pacific Islanders; Native Americans, American Indians, and Alaska Natives; and Transgender and Gender Nonconforming Community*) have conducted a combination of **supportive service, referral, linkage, outreach, and engagement** activities, related to COVID-19 for their respective communities.
- **Supportive services**
- **Referrals and linkages** to community members for COVID-19 testing, vaccinations, and other mitigation strategies were provided.
- **Outreach and engagement** activities related to the COVID-19 response and recovery were also conducted.

POPULATION HEALTH COLLECTIVES

Six Population Health Equity Collectives are building capacity within six priority communities (Asians, Native Hawaiians, and Pacific Islanders; Blacks and African Americans; Latinos; Older Adults; LGBTQ+; and Individuals with Disabilities).

***In June 2023, another Collective, the Food Security, Nutrition & Access Collective was added.**

Now that Health Equity Plans are complete (as of June 15th!) and now planning is underway to co-design a Year 2

Power Building Fund

- Organizations have **budgets of less than \$500,000**
- **19 additional organizations were added May 1st**
- **While the Round 1 Power Building grantees are currently 1/2 way through their trainings, the Round 2 grantees requested supports in these areas:**
 - **Fundraising/Development: 84%**
 - **Program Strategy & Planning: 79%**
 - **Civic Eng/Outreach/Mobiliz: 68%**
 - **Network/ Coalition building: 63%**
 - **Evaluation & Data: 63%**

Lessons Learned Year 1

- **Data Coordination and Utilization are Critical**
- **Reflecting on the data** collected is critical.
- Now that we have information on who is engaged with Equity in OC, it is time to step back and ask ourselves: *Who is missing from the table? Who can outreach to other communities and populations we may want to engage?*
 - *Added a Food Security, Access & Nutrition Collaborative*
 - *In dialogue with the SEA, NA groups about how they can engage more fully.*
 - *Trainings for Power Building grantees based on learnings from surveys.*
- **Centering Equity Requires Flexibility**
- Communicating 6 unique funding opportunities to the public required **extensive support to help organizations apply for opportunities** aligned with their work.
 - OC United Way hosted office hours, bidder's conferences, and online meetups where organizations could come together to potentially partner;
 - OPHE & IHI co-create CHILA experiences based on community needs that emerge and learnings from coaches

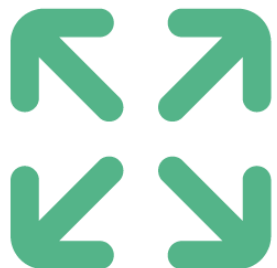

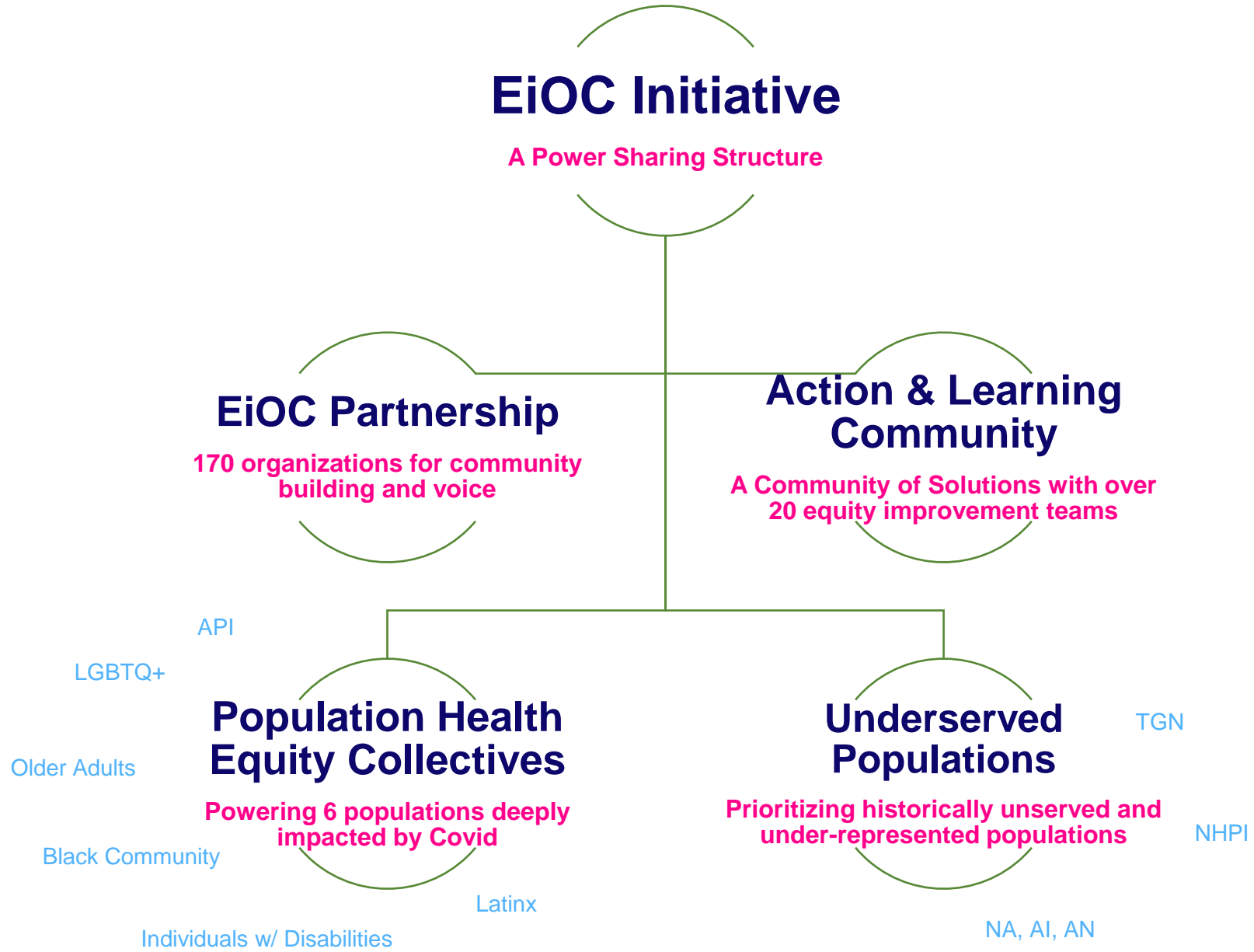

SYSTEM TOPICS

ACCESS AND SYSTEM NAVIGATION

The HIP will work with CalOptima and Be Well OC to meet our ideals of a public health system that is:

- responsive, accessible, and accountable to the communities it serves;
- well connected and coordinated across various sectors.

SOCIAL DETERMINANTS OF HEALTH

Goal: Achieve health equity by addressing the root causes that impact health outcomes across Orange County.

Goal 1: Increase the proportion of community members who are in a healthy weight category.

Health Promotion and Disease Prevention Goals, Objectives, and Strategies

HIP Planning Partner: HIP Health Promotion and Disease Prevention Work Group

The OC Health Improvement Partnership's Health Promotion and Disease Prevention Work Group guides efforts in this area. The work group reorganized in 2019 and is composed of members from the former OC HIP Obesity Work Group and the OC Diabetes Collaborative, which each previously addressed the Obesity and Diabetes priority area of previous Orange County Health Improvement Plans. Current members include community partners representing America on Track, American Diabetes Association, California State University at Fullerton, CalOptima, Community Action Partnership of Orange County, Dairy Council of California, First 5 Orange County, Kid Healthy, MOMS Orange County, Orange County Department of Education, Orange County Health Care Agency, PHFE Women, Infants, and Children Program (WIC), Providence St. Joseph, Southland Integrated Services, and University of California Cooperative Extension.

Goal 1 Increase the proportion of community members who are in a healthy weight category.

Objective 1: By December 2022, increase by 1% the proportion of economically disadvantaged children and adolescents who are in the healthy weight category.

Objective 2: By December 2022, increase by 0.5% the proportion of economically disadvantaged children and adolescents who are in the healthy weight category in Anaheim, Buena Park, La Habra, and Santa Ana.

Countywide Strategies:

- Coordinate consistent messages about obesity with health care providers.
- Provide resident leadership academy training.
- Provide capacity support to coalitions throughout Orange County.

Targeted Strategies for Anaheim, Buena Park, La Habra, and Santa Ana:

Support community-specific coalitions in implementing collective impact approaches including multi-sector interventions specified such as the following:

- Support implementation of school wellness plans.
- Collaborate with partners to assess Early Childhood Education sites that implement nutrition and physical activity standards and follow-up with technical assistance.
- Promote and expand community efforts involving parents and families.
- Identify ways to engage WIC participants up to five to improve a "healthy start" for nutrition.
- Build the capacity of residents to work with school districts, schools, Parent Teacher Student Associations and educators to expand Policy, system, and environmental changes.

Goal 2 Reverse the trend of increasing rates of diabetes.

Objective 1: By December 2022, hold the Type 2 Diabetes prevalence under current statewide rates of increase to 9.0%.

Strategies:

- Promote and expand availability and utilization of effective diabetes prevention and self-management programs by persons who are at risk for diabetes and living with pre-diabetes, diabetes, or gestational diabetes.
- Improve coordination of and communication about diabetes screening, diabetes prevention, and self-management education efforts to ensure that programs are accessible to all populations, with special emphasis on those at greatest risk.

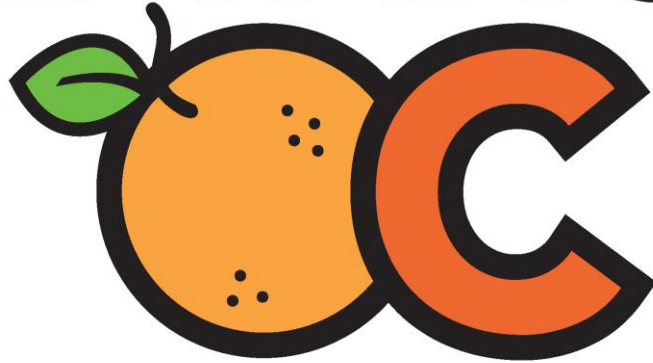

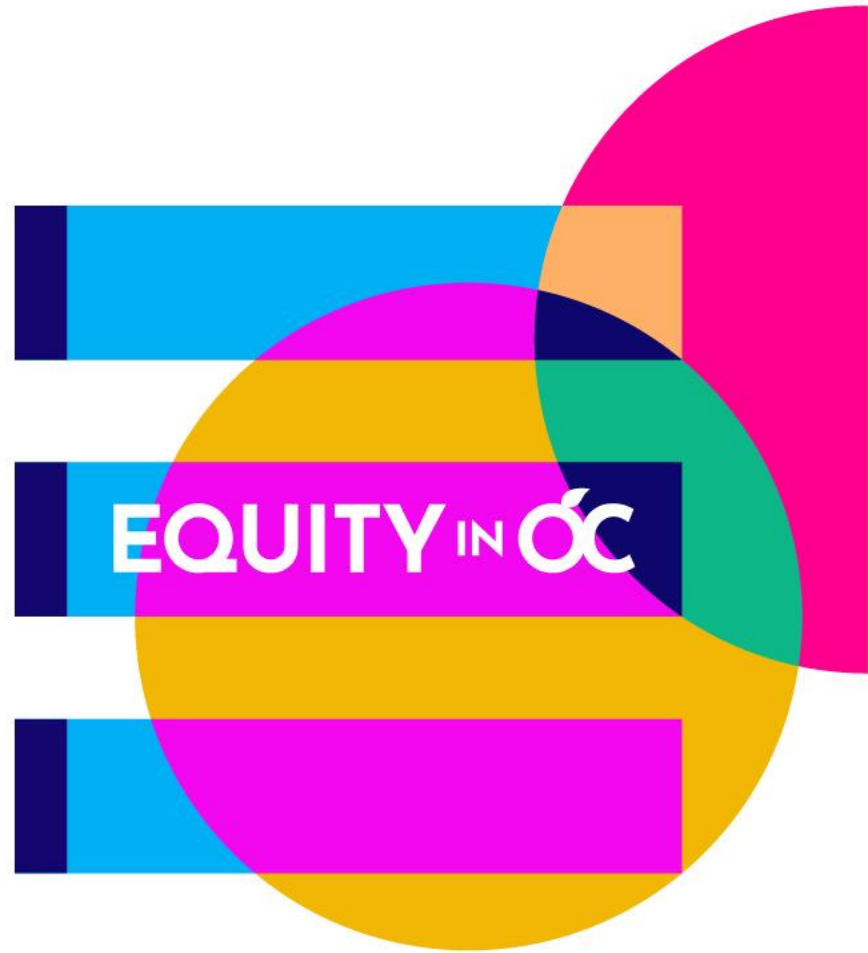
