Efficient Reconstruction: Anti-corruption and Transparency Initiatives

Panel discussion will cover current initiatives and the role of civil society in ensuring transparency and accountability of Ukraine's recovery. The panel is co-organized by the Ministry of Infrastructure of Ukraine, the Ukrainian think tank Better Regulation Delivery Office and USAID Support to Anti-Corruption Champion Institutions program in Ukraine (SACCI).

Post-war societies experience a serious authority crisis. Transparency and accountability are crucial for rebuilding a trustful relationship between society and the authorities. In addition, it is vital to guarantee more financial resources flow into Ukraine, which should convince donors that their money is well-spent and show the investors there's something to offset their security concerns.
