# CRI's Voice for Justice in the Courts, the Community, and Policy

**Telling the Stories that Change Lives** 

CRI works with legal defense teams to bring the stories of our clients' lives into the courtroom. Under the American Bar Association Guidelines, this process, called mitigation, is a constitutional right. As trained Mitigation Specialists, the CRI team conducts exhaustive investigations into our clients' lives going back three generations. It brings their experiences, their family history, and all they are as human beings to light to form a fuller picture for judicial representatives of circumstances and events that have affected their lives.





## **Training, Support, and Mentorship**

CRI trains and consults with attorneys and investigators. We offer pro-bono consultation and mentorship around issues of mental health, penalty phase investigation, and social histories for sentencing. Our internship programs invite high school and college students to research issues central to our work. CRI interns have organized awareness campaigns on the prison industrial complex, planned fundraisers for local organizations, and interviewed former clients and their families.



# **Support for Families and Communities**

CRI's Family Services program works with children and families of incarcerated people. We identify causes of inequity, instability, and incarceration and design supportive, deliverable programs to counteract these factors. Through this work, CRI supports families to alleviate the trauma of incarceration. CRI staff develop action plans with families struggling to maintain familial bonds and provide crisis intervention responding to specific family needs. This support may come in the form of purchasing clothing, finding housing,

and connecting families with outside organizations.

# **Sharing Joy Through Reading, Music, and the Arts**

CRI's programs bring children and their loved ones together through reading programs, and music and art programs that connect children with local artists and musicians to learn and play, to encourage creativity and to discover the healing power of art.

# **Advocacy & Organizing for Change**

CRI believes that public safety is more than jailing and policing. To this end, we work with community coalitions to expand the definition of safety to include social services, investment in community, and abolition of the death penalty.

"CRI and I have been through a lot of highs and challenges together. I was not the easiest client, because at first I did not trust anybody. But they became my mentors. I shaped a lot of who I am now from the things I learned to question. I learned how to become the man I am now with the help of CRI. They not only treat me as a client but as a person, a human being—I never really felt that before and it motivated me. I couldn't really read or write before CRI, let alone do a college course. I became an educated man because of CRI. They helped my legal team to get my sentence reduced. They did not give up on me. There's an adage that a friend is a person who stays in the room when everyone else walks out. CRI has shown that to be true."

# Become a Part of CRI's Story

In supporting individuals and communities impacted by the criminal legal system, we better the health of our society as a whole.
