ELIGIBILITY: The Sweepstakes is open to NBA Top Shot users (as defined as a user with an account at www.nbatopshot.com, and a valid email address associated with that account), who have not purchased a Starter Pack prior to April 26, 2022, that have successfully completed identity verification, that follow @nbatopshot on Twitter and/or Instagram, and who are of the age of majority in the jurisdiction of their residence.
