

### **G3 Case Study Questionnaire**

#### **1. What pseudo name do we want to give the client?**

#### **2. What occurred that caused them to need an attorney? Car Wreck? Accident?**

According to relevant reports and statements, our client, Daisy White, was operating a motor vehicle traveling east on Highway 63 in LaFollette, Campbell County, Tennessee. A vehicle operated by Hank Gray, was traveling west on Highway 63 in LaFollette, Campbell County, Tennessee. As Mr. Gray was traveling west on Highway 63, a piece of large, heavy machinery fell off his trailer due to an improperly secured load. Ms. White was traveling eastbound when the machinery fell onto the roadway and then struck her vehicle causing her to run off the roadway. The piece of machinery in tow was an extension for an asphalt paver. As the extension was improperly secured on the paver by makeshift metal pins by Mr. Gray, clearly Ms. White does not have any comparative fault in this matter.

#### **3. How did this accident affect them/and or their family (injuries, monetary loss or struggle, etc.)?**

Ms. White was seen at LaFollette Medical Center for her injuries including but not limited to, strain of muscle, fascia and tendon at the neck level, right hand injury, severe right arm burn due to the airbag, cellulitis of her right wrist, spondylosis with radiculopathy at the cervical region, small multilevel posterior disc osteophyte complexes with uncovertebral arthropathy contributing to mild spinal canal stenosis at C3/C3-C6/C7 and multilevel neural foraminal narrowing most notable at the levels of C3/C4, C4/C5 and C6/C7. As a result of the traumatic event, Ms. White also experienced severe anxiety as the scene of the accident due to the events. She also underwent two procedures: a cervical epidural steroid injection using catheter placement to the left C3/C4 level using fluoroscopic guidance and a left C2-C3 (third occipital nerve) and C4 and C5 medial branch nerve blocks using fluoroscopic guidance.
