Case: 48701 Remove popup window when exporting PDF/Excel reports

When generating formatted PDF or Excel files, for example the reports under the All Reports menu, or the Invoice print preview, or the Batching preview, etc. the file will now be generated without using a popup window. When you click the button your browser will either download or open the file directly (depending on which browser and user preferences) so you won't need to close an empty popup after it downloads.

Case: 48327 FAFSA Change report

New FAFSA Change Report (Info by Aid Year menu) displays most recent application received and the current application information where the two sequence numbers are different. The purpose of this report is to identify EFC changes and/or when a new C Flag comes in on a newer app.

Case: 48328 ISIR Comment report

New report shows ISIR Comment Code information by student (Info by Aid Year menu).



FASTFINANCE

Case: 48916 Alt Hierarchies after running a Pinned Report

Fixed a bug on the Trial Balance report: after running a Pinned Report that did not use alternate hierarchies, and then adding alternate hierarchies and re-executing the report, the selected alternate hierarchies were not picked up.

Case: 48760 Add Contract Type filter to 2 Jobs reports

Added Contract Type filter to the All Jobs and Current Jobs reports.

Case: 48827 Update fnFiscalYear to pull from PTRCALN instead of vwfsperiod

Update logic to pull Fiscal Year from HR calendar rather than derive from Finance calendar.

Case: 48860 Add Leave Reason type to Employee Benefit

Add Leave Reason Type and Description to Employee Benefit Deduction information.

Case: 48979 Job Comments - add ability to show multiple comments based on one date

Update job comments logic to display multiple job comments when there are more than one for a given effective date.

Case: 48406 Require at least one approval before submitting to central

Added configuration setting #799 "Require at least one approval before submitting to Purchasing? (Y/N)" to control whether card holders can submit directly to Purchasing/central approval or whether they need to submit to their supervisors first.

Case: 48588 Additional approval options

Added the ability to specify direct approvers for specific accounts on the Account Administration setup screen.

Created configuration setting #798 "Approval structure (DEPT, DIRECT, BOTH)" to control whether the search filter for Approvers on the Approval screen looks at the Department Hierarchy, at the Account Administration direct approvers, or both.

Case: 48904 Invalid Student Cohort Codes

Fixed an issue if a cohort was ended without adding a new cohort, FAST incorrectly still selected invalid cohort as being current.

Case: 48908 Correct Program filter on the Registered Credit Hours report

Previously, an error was encountered when the program filter was used. This issue has been resolved.



Case: 48956 The Student Info warehouse step is specific situations could miss creating a term record if only activity was from transfer

Fixed an issue where a table join could cause a term to be missed if the only activity was from course history.



Global Changes That Affect All Applications

Case: 47233 Unique Records checkbox becomes disabled

Fixed a bug on the Advanced Options tab where the "Display only unique records" checkbox would not become re-enabled after removing/no longer using Group Functions.

Case: 48516 Add Tooltip on Search Box Multi Filter Compare Options

Added a tooltip to the SearchBox Multi filter with some helpful usage tips:

- Click the magnifying glass icon to search.
- If you know a specific value, you can type it in without searching.
- Entering a comma separated list of values will split automatically into individual values.
- Enter a: to set a range, for example A:Z.
- Enter a % for a wildcard, for example A% (starts with) or %Z (ends with) or %A% (contains).

Case: 48797 Query comments

Fixed a bug when saving a query in the Query Builder and specifying comments: if more than 100 characters of comments were entered an error would appear stating that the max length is 4000 characters. You can now properly add comments longer than 100 characters up to a maximum of 4000 characters.
