SUBJECT: A Resolution to Appropriate Tribal Funds to the Housing Authority of the Cheyenne and Arapaho Tribes, Department of Housing to alleviate tribal elders' city code violations for lack of lawn care and yard maintenance.

WHEREAS: The Cheyenne and Arapaho Tribes ("Tribes") are federally recognized Indian tribes, organized under a Constitution approved by Tribal membership on April 4, 2006, and approved by the Secretary of the Interior; and

WHEREAS: Article VI, Section 5(a) and (c) in the Constitution provides that "Legislative power shall be vested in the Legislature" and "the Legislature shall have the power to make laws and resolutions in accordance with the Constitution which are necessary and proper for the good of the Tribes;" and

WHEREAS: Article VI, Section 5 (d) of the Constitution authorizes the Legislature shall have the power to raise revenue and appropriate funds for expenditure; and

WHEREAS: lawn care is requested annually for yard maintenance for the elderly throughout our service area and communities who are in desperate need of lawn service due to health and municipality code violations and cannot be paid from federal housing funds; and

WHEREAS: The Cheyenne and Arapaho Tribes support this fair and needed resolution for the safety and health of property for tribal elderly homeowners and homebuyers; and

WHEREAS: lawn maintenance will minimize the risk of health and property value loss by routine maintenance of overgrowth of lawns and minimize dangers of fire due to drought conditions; and

WHEREAS: \$413,000.00 of the tribal funds will go towards the purchase of lawnmowers; and

WHEREAS: the tribal elders who accept a lawnmower, no contracting services will be allowed

for 4 years; and

WHEREAS: \$45,000.00 of the tribal funds will be allowed for contracting services for the

elderly who are unable, or disabled to carry out routine lawn care.

NOW THEREFORE BE IT RESOLVED that the Tenth Legislature of the Cheyenne and Arapaho Tribes, finds it necessary and proper for the good of the Tribes and hereby approves to appropriate the sum of \$455,000.00 in tribal funds; and

BE IT FURTHER RESOLVED that the Tenth Legislature of the Cheyenne and Arapaho Tribes hereby authorizes the Housing Authority of the Cheyenne and Arapaho Tribes, Department of Housing tribal funds to purchase lawnmowers and/or provide lawn care contract services to benefit tribal elderly homeowners and homebuyers.

Pursuant to Article VI, Section 7, subsection (a)(iv) of the Tribes Constitution reads in part: "All Bills passed by the Legislature shall be presented to the Governor for signature or veto. All laws shall take effect thirty days after signature by the Governor or veto override by the Legislature unless any Member of the Tribes submits to the Coordinator of the Office of Tribal Council a petition signed by at least one hundred fifty Members of the Tribal Council seeking to repeal the law or resolution at the next Tribal Council meeting. If the Tribal Council fails to repeal such law or resolution at the next Tribal Council where the matter has been properly placed on the agenda for the Tribal Council meeting, such law or resolution shall become effective immediately."

Pursuant to Article VII, Section 4, subsection (g) of the Tribes Constitution reads: "The Governor shall have the power to sign any enactment passed by the Legislature into law or to veto any enactment passed by the Legislature within ten days of passage with a written explanation of any objections; and if the Governor takes no action within ten days, then the enactment shall become law in accordance with this Constitution."
