• How will we use your data?

In general, your personal data will be used to interact with you and provide you with our services. Additionally, they may be used for other activities such as sending you advertising or promoting our activities.

Why do we need to use your data?

Your personal data is necessary for us to interact with you and provide our services. In this regard, we will provide you with a series of checkboxes that will allow you to decide clearly and easily on the use of your personal information.

• Who will have access to the information we request?

In general, only the authorized personnel of our organization will have knowledge of the information we request. Likewise, entities that need access to your personal information to enable us to provide our services may also have knowledge of it. For example, our bank will be aware of your data if the payment for our services is made by credit card or bank transfer.

Additionally, public or private entities to which we are obliged to provide your personal data due to the fulfillment of any law may have knowledge of your information. For



instance, the Tax Law requires providing the Tax Agency with certain information about economic transactions that exceed a certain amount.

In cases other than those mentioned, if we need to disclose your personal information to other entities, we will seek your permission beforehand through clear options that allow you to decide in this regard.

How will we protect your data?

We will protect your data with effective security measures based on the risks associated with the use of your information. Our organization has approved a Data Protection Policy, and annual controls and audits are conducted to verify that your personal data is secure at all times.

Will we send your data to other countries?

There are countries in the world that are safe for your data, and others that are not. For example, the European Union is a secure environment for your data. Our policy is not to send your personal information to any country that is not safe from a data protection perspective. In the event that, to provide the service, it is essential to send your data to a country that is not as secure as Spain, we will always request your permission in advance and apply effective security measures to reduce the risks of transferring your personal information to another country.

How long will we keep your data?

We will retain your data during our relationship and as long as required by law. Once the applicable legal deadlines have expired, we will proceed to securely and environmentally responsibly delete them.

What are your data protection rights?

At any time, you can contact us to find out what information we have about you, correct it if it is incorrect, and delete it once our relationship is finished, if legally possible. You also have the right to request the transfer of your information to another entity. This right is called "portability" and can be useful in certain situations. To request any of these rights, you must submit a written request to our address, along with a photocopy of your ID to identify yourself. In our organization's offices, we have specific forms to request these rights and offer our assistance in completing them.

Can you withdraw your consent if you change your mind later?

You can withdraw your consent if you change your mind about the use of your data at any time. For example, if you were interested in receiving advertising for our products or services in the past but no longer wish to receive such advertising, you can notify us through the opposition form available in our organization's offices.

• If you believe your rights have been ignored, where can you file a complaint?

If you believe that your rights have been ignored by our organization, you can file a complaint with the Spanish Data Protection Agency through one of the following means:

• Will we create profiles about you?

Our policy is not to create profiles about users of our services. However, there may be situations where, for the purpose of service provision, commercial reasons, or others, we need to create profiles of information about you. An example could be the use of your purchase or service history to offer products or services tailored to your tastes or needs. In such cases, we will apply effective security measures to protect your information from unauthorized individuals who may attempt to use it for their own benefit.

Will we use your data for other purposes?

Our policy is not to use your data for purposes other than those explained to you. If, however, we need to use your data for different activities, we will always request your permission in advance through clear options that allow you to decide in this regard.
