

FACTS	WHAT DOES FTX US DO WITH YOUR PERSONAL INFORMATION?
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	<p>The types of personal information we collect and share depend on the product or service you have with us. This information is identified with specificity in our Privacy Policy, and can include:</p> <ul style="list-style-type: none"><li>• Social Security number</li><li>• Account profile information, such as your name, email address, phone number, and physical address</li><li>• Assets, income, and employment information</li><li>• Investment experience and risk tolerance</li><li>• Account balances and payment history</li><li>• Transaction information related to purchases and sales of cryptocurrency and NFTs</li></ul>
How?	All financial companies need to share customers’ personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers’ personal information, the reasons FTX US chooses to share, and whether you can limit this sharing.

What we do	
How does FTX US protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does FTX US collect my personal information?	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"><li>• open an account or deposit money; or</li><li>• use your credit or debit card or make deposits or withdrawals from your account;</li><li>• give us your contact information; or tell us who receives the money.</li></ul> <p>We also collect your personal information from others, such as from credit bureaus, affiliates or other companies.</p>
Why can't I limit all sharing?	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"><li>• sharing for affiliates' everyday business purposes—information about your creditworthiness</li><li>• affiliates from using your information to market to you</li><li>• sharing for nonaffiliates to market to you</li></ul> <p>State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.</p>
Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies: Our affiliates include FTX Trading Ltd. and companies with a common name including, without limitation, West Realm Shires Inc. and West Realm Shires Financial Services Inc.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

**Special Notice for California Residents:** Under California law, we will not share the nonpublic information that we have about you with non-affiliated third parties or our family of companies except for permissible legal purposes, including those permitted under Cal. Fin. Code § 4056. Examples of permitted purposes include effecting or administering transactions, at your direction and with your consent or as necessary to protect against fraud, identify theft or unauthorized transactions.

**Special Notice to Vermont Residents:** We will not disclose information about your creditworthiness to our affiliates and will not disclose your personal information, financial information, credit report, or health information to nonaffiliated third parties to market to you, other than as permitted by Vermont law, unless you authorize us to make those disclosures.

**Special Notice to Kentucky residents:** We will not sell or transfer your personal information without your authorization and without putting in place required confidentiality provisions.
