This announcement is made by the Company pursuant to Rule 13.09(2)(a) of the Listing Rules and Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance.

The Board wishes to inform the shareholders of the Company and potential investors that, based on the preliminary review of the Group's unaudited management accounts for the six months period ended 30 June 2019 and information currently available to the Board, the Group expects to turn profitable as compared to a net loss of HK\$ 33 million recorded by the Group in the same period last year.

**Shareholders of the Company and potential investors are advised to exercise caution when dealing in the shares of the Company.**

This announcement is made by Hung Hing Printing Group Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(2)(a) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Future Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors (the “**Board**”) of the Company wishes to inform the shareholders of the Company and potential investors that, based on the preliminary review of the Group's unaudited management accounts for the six months period ended 30 June 2019 and information currently available to the Board, the Group expects to turn profitable as compared to a net loss of HK\$ 33 million recorded by the Group in the same period last year. The expected turnaround is mainly attributed to improved gross profit margin

due to: (a) pricing of papers experienced moderate downward pressure and relatively more rational adjustments following certain hikes seen in 2018; (b) favourable currency exchange movements on operating costs; (c) effective control of labour cost; and (d) efficiency improvement from automation and redesign of workflows tally with rationalization of orders portfolio for value enhancement.

The Company is in the process of finalizing the Group's interim results for the six months ended 30 June 2019 (the “**Interim Results**”). The information contained in this announcement is only a preliminary assessment by the management of the Company based on the latest management accounts of the Group currently available and is not based on any figures or information which has been audited or reviewed by the Company's auditors. Finalized Interim Results and other details of the Group are expected to be announced before end of August 2019.
