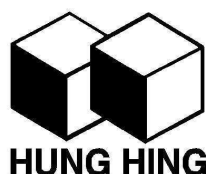

### **CLARIFICATION ANNOUNCEMENT**

The total comprehensive income for the year ended 31 March 2010 that appears in the Annual Results Announcement was inadvertently stated to be HK\$194,467,000 instead of HK\$192,467,000. Further, the total comprehensive loss for the year ended 31 March 2009 that appears in the Annual Results Announcement was inadvertently stated to be HK\$162,022,000 instead of HK\$162,342,000.
