### a. Karl McDermott discussion with ICE & staff

# b. Discuss re-aligning the FIT Reporting Quarterly

The Board were advised that information in support of the Feed-In-Tariff (FIT) will be requested as needed by the RA and monthly data is obtainable for internal tracking purposes. The RA will consider minimum filing requirements in order to support the RA's ability to identify trends in pricing data.

### 2. Google Update

The Board received an update on Google's plans with respect to the Nuvem Submarine Cable system and the requirements for a permit and licence application under the Submarine Communications Cable Act 2020.

# a. Clarien Line of Credit (For Approval)

The RA's line of credit with Clarien Bank Ltd is scheduled for renewal effective January 2024, for an additional two-year term. The Board unanimously agreed to renew the RA's line of credit with Clarien Bank Ltd for an additional two-year term.
