DISCLOSURES

1. Cardinal Capital Management, Inc. is an independent portfolio manager registered under the Manitoba Securities Act, S50. Policies for valuing investments, calculating performance, and preparing GIPS Reports are available upon request.
2. The Canada Plus Balanced Composite includes all segregated (separate portfolios) fee-paying discretionary balanced portfolios that have a 40% to 90% allocation to Canadian and non-Canadian common equities, with a typical allocation of 60% to 80%. Within the equity portion, portfolios have a 50% to 100% allocation to Canadian common equities and investment trusts, with a typical allocation of 60% to 80%. A 0% to 50% allocation to non-Canadian common equities and investment trusts, with a typical target allocation of 20% to 40%. A total portfolio allocation of 10% to 60% allocation to Canadian provincial and corporate bonds, with bonds typically rated 'A' or above, with a typical target allocation of 20% to 40%. The composite was redefined effective January 1, 2021 to allow for inclusion of equity and/or fixed income pooled funds or mutual funds. Portfolios do not utilize derivative instruments, hedging or leverage. This composite includes both taxable and non-taxable portfolios. The minimum asset value of portfolios in the composite is \$10,000.
3. The custom benchmark: The weighted benchmark is comprised of taking the approximate blend for each month between the market value of Canadian equities, non-Canadian equities and bonds. For instance, if in a given month the market value of Canadian equities was 50%, U.S. equities was 20%, international equities was 10% and bonds was 20%, then the weighted benchmark would be derived by the sum of 50% of the performance of the S&P/TSX Total Return Index, 20% of the S&P 500 Total Return CAD Index, 10% of the MSCI EAFE Total Return CAD Index and 20% of the FTSE TMX Canada Universe Bond Index.
4. Valuations are computed and performance is reported in Canadian dollars.
5. Returns represent past performance. Past performance does not guarantee future results. Returns shown are total returns, including realized and unrealized gains and losses plus income.
6. Gross-of-fees returns are presented before management fees but after the deduction of brokerage commissions and applicable non-resident withholding taxes paid. Net-of-fees returns are calculated by deducting actual management fees from the gross-of-fees returns. The firm's annual fee schedule is as follows:

7. This composite was created in 2013. The composite's inception date is July 1, 2013. A complete listing and description of the firm's composites is available upon request. The firm's list of pooled fund descriptions for limited distribution pooled funds is also available upon request.
8. Internal dispersion is calculated using the size-weighted standard deviation of the annual gross-of-fees returns of all portfolios that were included in the composite for the entire year.
9. The three-year annualized ex-post standard deviation measures the variability of the composite's gross returns and the benchmark over the preceding 36-month period. The standard deviation is not presented for 2013 through 2015 because monthly composite and benchmark returns were not available for the last 36 months.
