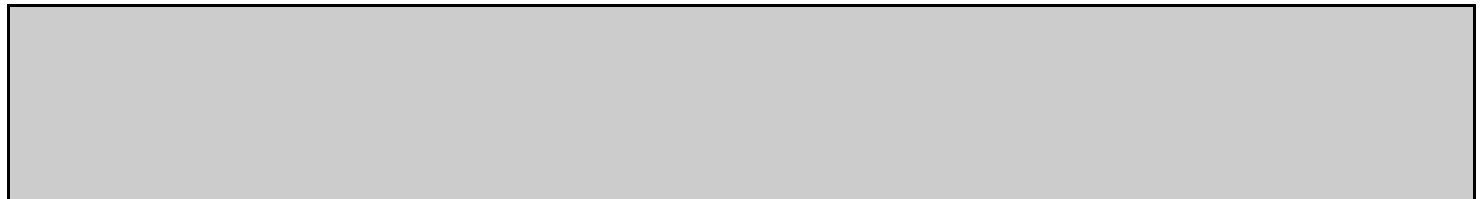

## 1) HOW TO PAY THIS NOTICE:

1.1) **ONLINE PAYMENT:** Go to [www.go-pass.com](http://www.go-pass.com), and follow the online instructions. You must have this Notice and Account Numbers, and credit or debit card information to make your payment online. Sign for GO-PASS Auto-Bill to save time and money!

1.2) **BY MAIL (full payment only):** Detach and return the bottom portion of this notice, and enclose a check, cashier's check, or money order payable to Northwest Parkway for the full amount of this notice. Please write the Notice number on your check, cashier's check or money order.

## 2) IF YOU ARE:

2.1) **"GO-PASS Auto-bill" Customer:** you may have received this Past-Due Notice ("Notice") if NWP was unable to collect through your Credit Card or your vehicle information is not up-to-date. Please call 303-926-2500 and a Customer Service Representative will assist you in updating your account information. Please have the following information available when you call: 1) Name as it appears on your GO-PASS account and/or the account number; 2) All current license plate numbers. Fees may still apply.

2.2) **"ExpressToll" Customer:** you may have received this Notice if your vehicle information (license plate) is not up-to-date or your ExpressToll account is not in good standing. To update your ExpressToll account please call (303) 537-3470 or 1 (888) 946-3470 (out-of-area), and a Customer Service Representative will assist you. Once your ExpressToll account has been updated, future transactions will be billed directly through your ExpressToll account. **You will still be responsible for making the payment on this GO-PASS account.** Please follow the payment instructions above on 1).

## 3) DISPUTE:

If you wish to dispute your responsibility for these charges, please contact the Northwest Parkway at Violation Processing Center, 3701 Northwest Parkway, Broomfield, CO 80023 in writing within twenty-five days of the date of this Notice.

*Please include the Notice number, your name, and license plate number along with your contact information (phone number and/or email).*

### 3.1) Instructions for Sold/Stolen Vehicles:

If the vehicle was sold/transferred or stolen at the time(s) of travel(s) in this Notice, you can mail the Notice with required documentation to:

Dispute	Documentation Required
Sold/Transferred Vehicle	Certificate of Vehicle Title Transfer or properly executed Bill of Sale, dated prior the toll activity
Stolen Plate or Vehicle	Police Theft or Recover Report identifying the date of theft or recovery or an Insurance Policy (Theft) Payoff report

Failure to include the above documentation may result in a continuation of the collection proceedings as highlighted below.

**Toll evasion may be deemed a theft of service. The following are not legal defense or mitigating factor under Colorado law: 1) the Notice was not sent sooner; 2) the driver did not intend to use the Northwest Parkway; or 3) someone else was driving the vehicle.**

**Failure to pay in full the outstanding tolls and fees, or to dispute this Notice, may result in the charge being turned over for collection and/or further legal action.**
