## ENTRY REQUIREMENTS

Learners must be able to communicate in English (reading, writing, speaking and listening). Learners must be 18 or over to undertake this qualification and to apply for the necessary SIA licence to work. Learners must provide evidence that they hold a valid Emergency First Aid qualification or equivalent which should be equal to or above a Level 3 (RQF/QCF) or Level 6 SCQF Emergency First Aid at Work qualification. ## ASSESSMENT

Assessment is by multiple choice examination and internally assessed practical demonstrations. **Three** externally set and externally marked multiple choice exams marked by **LASER**.

Each exam:

- is administered by centre staff under examination conditions.
- assesses one unit.
- lasts between 10 and 45 minutes.
- See Qualification Specification for individual unit requirements.

For the Physical Intervention (PI) unit learners must achieve 100% from an oral question and answer session covering critical areas of PI knowledge.

In addition, learners must successfully complete **two** internally assessed practical activities.
