The Ness County Board of Commissioners met in regular session Monday, February 5, 2024, at 9:00 a.m. in the Ness County Commissioner Chambers. Chairman Mark Davis called the meeting to order with Commissioners Travis Petersilie, Dave Albers, and County Clerk Lori Hertel in attendance.

Noxious Weed

Noxious Weed Department Chilton Miller met with Commission to discuss contract with KDOT for spraying Highway ditches and billing for prairie dog eradication. Commission reviewed an invoice dispute and discussed extra lawn mower housed at Noxious Weed building.

Road and Bridge

Ness County Road and Bridge/Landfill Supervisor Ron Johnson presented grader hours on equipment. Discussion on older equipment in need of replacing, road conditions, & citizen complaints were addressed. An agreement was signed with KDOT for Off System 37 Bridge project. The weekly work schedule was presented. Employment application was reviewed.
