LOCAL LAW NO. 1-2021**

**A LOCAL LAW TO OPT-OUT OF THE RETAIL DISPENSARY LICENSE AND/OR  
ON-SITE CONSUMPTION LICENSE PROVISIONS OF CHAPTER 7-A OF THE  
CONSOLIDATED LAWS OF THE STATE OF NEW YORK**

BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF WALES AS FOLLOWS:

**SECTION 1. TITLE.**

This Local Law shall be known, cited and referred to as the "Town of Wales Adult Use Cannabis Retail Dispensaries and/or On-Site Consumption License Opt-Out."

**SECTION 2. PURPOSE AND INTENT.**

The purpose of this Local Law is to enable the Town of Wales to opt-out of the provisions relating to the Cannabis Control Board's authority to issue Retail Dispensary Licenses and/or on-site Consumption Licenses for cannabis pursuant to Chapter 7-A of the Consolidated Laws of the State of New York within the jurisdiction of the Town of Wales.

**SECTION 3.**

The Town of Wales hereby requests that the Cannabis Control Board prohibit the establishment of any Retail Dispensary Licenses and/or On-Site Consumption Licenses as provided for in Article 4 of Chapter 7-A of the Consolidated Laws of the State of New York within the jurisdiction of the Town of Wales.

**SECTION 4. PERMISSIVE REFERENDUM.**

This Local Law is subject to permissive referendum as provided under the Municipal Home Rule Law of the State of New York.

**SECTION 5. EFFECTIVE DATE.**


This Local Law shall take effect upon expiration of the time period for filing a Petition for Permissive Referendum pursuant to Municipal Home Rule Law and filing with the Secretary of State.
