## NOTICE OF PUBLIC HEARING ON THE LOCATION ASPECTS AND NOTICE OF AVAILABILITY OF THE ENVIRONMENTAL ASSESSMENT FOR THE PROPOSED IMPROVEMENT OF INTERSTATE HIGHWAY 41 BETWEEN WIS 96 AND COUNTY F OUTAGAMIE AND BROWN COUNTIES

ALL INTERESTED PERSONS are advised that the Wisconsin Department of Transportation (WisDOT) will hold a public hearing as provided by law to consider the general location and design features of the proposed improvements and the preferred alternative being considered for the Interstate 41 (I-41) project, including those aspects that will require authorization from the U.S. Army Corps of Engineers for the placement of fill materials into waters of the United States.

The proposed improvement would include:

- Reconstructing 23 miles of I-41 with an additional travel lane in each direction
- Reconstruction of nine existing interchanges
- Construction of one new interchange
- Updating the outdated Wrightstown Safety and Weight Enforcement Facility (SWEF) to allow it to operate effectively with proposed improvements to I-41
- Move the Northeast District State Patrol Headquarters to the Wrightstown SWEF including a new communication tower
- Resurfacing three existing park and ride lots and construction of an expanded salt shed at the Outagamie County Highway Department

It is anticipated that approximately 95 acres of new right of way, two residential relocations, and two business relocations will be needed for this project. The acquisition of necessary right of way is tentatively planned to begin in 2023 or 2024.

Land acquisition and schedules for construction will be discussed at the public hearing. Relocation assistance will also be discussed. It is anticipated that the relocation of persons and businesses will occur as a result of the proposed improvement. Any person who feels that he or she may be thus affected by the proposed improvement may obtain relocation assistance information at the Department's Northeast Region Real Estate Office, (920) 360-3791.

The virtual public hearing component will begin at 6 p.m. and will end when all interested persons have provided testimony or 8 p.m., whichever is earlier. The virtual public hearing will begin with an informational project presentation prior to accepting verbal public testimony. Instructions on how to give verbal testimony publicly through YouTube Live or privately by phone to a court reporter will be provided at the virtual public hearing. Instructions will also be available on the project website after July 2, 2021.

The in-person public hearing components will be held on Wednesday, July 28, 2021, at Hemlock Creek Elementary School, located at 1900 Williams Grant Dr, De Pere, WI and on Thursday, July 29, 2021 at Fox Valley Technical College, D.J. Bordini Center, 5 N Systems Dr, Appleton, WI. The in-person public hearings will be conducted from 5 to 8 p.m.

Attendance at the in-person hearing will be by appointment only. Interested persons that have made an appointment may attend the in-person component public hearing to review displays and other hearing materials, ask questions, and provide testimony. Information provided when making an appointment (including names, addresses, phone numbers, e-mail addresses, and signatures) is not confidential, and may be subject to disclosure upon request, pursuant to the requirements of the Wisconsin open records law, sections 19.31—19.39 of the Wisconsin Statutes. If anyone arrives without an appointment, they may be asked to wait until space is available to accommodate their attendance to ensure occupancy restrictions are maintained.

Due to the COVID-19 pandemic, enhanced safety measures will be applied to the in-person public hearings. Guidelines from the Centers for Disease Control and Protection and the Wisconsin Department of Health Services will be followed. Vaccinated individuals may continue to wear face coverings but are not required to do so. All unvaccinated attendees are asked to wear a face mask and physical distance while in attendance at the in-person public hearing.

At the in-person public hearing component, project staff will be available for informal discussion to explain the project and answer questions. Exhibits will be on display and a statement about the project will be available for review. A continuous looping presentation about the project will also be available for viewing.
