# Device Setup

### Download the app

Download the Earzz app from the Android Google Play Store or the Apple App Store.

The Earzz app walks you through setting up and managing your Earzz Home Monitor.




## Set up your new Earzz Home Monitor.

In the Earzz app, select 'Add a new device' and follow the in-app instructions to set up your Earzz Home Monitor.

Please ensure your mobile device is connected to your preferred WiFinetwork to be used by your Earzz Home monitor and you have your wifi password ready for this step. See below for key screens/actions from the device setup process in the Earzz app. Once you have successfully connected your Earzz Home monitor, the middle and bottom LED will turn solid.

# **Device Operation**

### Pick the right spot for your Earzz Home Monitor:







When setting up your Earzz Home Monitor, choose a spot where your Earzz Home Monitor will be upright and unobstructed and away from rain or moisture and sources of loud noises such as TVs and speakers. Only to be used indoors. Set your Earzz Home Monitor near the source of the sound you wish to identify to ensure that the sound remains audible - i.e., loud enough for your Earzz Home Monitor to capture it.

### Power Up/Down the Earzz Home Monitor:







Press down the power button to turn on/off the device. The ring LED on the top indicates that the device is powered on.

Tips: Plug your Earzz Home Monitor into a power socket through the USB-C port on the back of the Earzz Home Monitor using the USB cable supplied.

For optimum performance, keep the Earzz Home Monitor

### Bluetooth Pairing your Earzz Home Monitor:



Press and hold the power button for 5 seconds until the ring LED begins blinking. Once the Earzz Home Monitor device successfully pairs with the Eazz app, the top side LED will turn solid Tips:

- Switch on your Bluetooth on your mobile/tablet device. Bluetooth must be enabled on your pairing device to pair with your Earzz Home monitor.
- Maké sure to pair only one Earzz Home monitor at a time.
  Ensure the Earzz Home monitor is close to your mobile/
- tablet device

Mute/Unmute your Earzz Home monitor microphone: You can turn on/off the microphone of your Earzz Home Monitor by tapping on the "Edit device settings" button and disabling the microphone.



The bottom LED will turn solid when the microphone is on. The bottom LED will blink when an audible sound is heard. The bottom LED will turn off when the microphone is muted.

### Select sounds to be recognised

Once you have set up your device, you can set your Earzz Home Monitor to listen for sounds through the sound selection screen in the Earzz app. This is done by simply tapping on the sounds you wish to listen for in the sound selection screen - a representative example is shown in the screen above.


Please note that the Earzz Home Monitor aims to notify users for recognised sounds of interest within a few seconds from when the Earzz Home Monitor captures an audible sound. This, however, may vary due to network, battery operation and other performance factors. Please ensure your Earzz Home Monitor is within the WiFi range.



### **Factory Reset**

You can reset/disconnect your Earzz Home Monitor by following two simple steps: Remove your Earzz Home Monitor from your Earzz app. You can do this by signing into the app and selecting "Edit device settings" for the Earzz Home Monitor you wish to disconnect. Then, select the "Disconnect Device" button at the bottom of the device settings page.

Once you have removed/ disconnected your Earzz Home Monitor from the Earzz app, press and hold the main power button of the Farzz Home Monitor for 10 seconds while the device is powered up until the side LEDs start blinking. Once the device has completely reset, the top ring LED will remain solid. The device is now ready to be set up again.





You can provide feedback for the sounds of interest selected and recognised by the Earzz Home Monitor AI algorithm. Each notification allows for a YES/NO option to be displayed to reaffirm whether the specific notification was accurate. Submitting feedback for notifications received will allow the Al algorithm to be improved.





## Keeping track of sounds

You can also keep track of all the notifications in the sound log screen within the app. Simply tap the sound log option in the menu bar to see the list of sounds recognised by your Farzz
