**A Resolution to Bestow Emeritus Status on Hannah Siegel**

## **Introduction**

During the 2021-2022 cohort of the Ambassador Program, Hannah Siegel (Southern Methodist University) served as Ambassador Co-President and Treasurer of the Ambassador Program. Hannah served the Ambassador Program faithfully and dutifully in these roles during the program's inaugural year. Her leadership exemplifies the values of the program and sets a strong precedent for future officers. Hannah's contributions warrant recognition.

## **Articles**

### **Article I: Recognition of Work**

- I. Hannah served faithfully and dutifully the offices of Ambassador Co-President and Treasurer during the 2021-2022 cohort of the Jewish on Campus Ambassador Program.
  - A. Hannah's dedication manifested into the success exhibited by the 2021-2022 cohort, particularly in her work with individual ambassadors to resolve issues on their campuses.
  - B. Hannah's leadership was exemplary during Open Forums, educational sessions, and other meetings, setting a strong example for future officers.
  - C. Additionally, the Ambassador Program applauds Hannah's energetic and kind personality in all her interactions with ambassadors, creating a welcoming atmosphere for Jewish advocates across the continent.
- II. In particular, the Ambassador Program recognizes Hannah's essential role as the inaugural office-holder for her offices during the program's initial cohort.
  - A. The Ambassador Program will forever hold a debt of gratitude to Hannah for her steadfast commitment to the betterment of Jewish student life in North America.

### **Article II: Bestowal of Emeritus Status**

- I. The Jewish on Campus Ambassador Program formally grants Hannah the titles of Ambassador President Emeritus and Ambassador Treasurer Emeritus.
  - A. These titles are purely ceremonial and carry no authority under the Constitution, but are an expression of gratitude from the Ambassador Program for Hannah's work as an officer.
- II. The titles are bestowed upon Hannah immediately upon passage of this resolution.
