FOSTER PARENT PROGRAM



Mission Statement:

Our mission is to protect, aid and heal children by strengthening families through the provision of traditions, ceremonies, and culturally relevant services.

OBJECTIVE

To provide children with a temporary, safe, and stable home; while our protection unit works with the birth family to strengthen and reunite them.

TYPES OF FOSTER HOMES

There are different types of foster care placements including;

- short term
- emergency
- respite
- long term placements

The child's needs will dictate the type of placement needed.

Our plan is to work with you to determine your interest and abilities to foster.

Specific Requirements:

Each prospective foster parent must:

- Complete a family self assessment as part of screening process.
- Attend 30 hours of training. [see foster home worker or family services supervisor for more details].
- Provide a Criminal Record Check [all residents of the home 18 years of age and over must submit a Criminal Record Check]
- Provide a Medical Report from your family physician.
- Provide 5 references.
- Provide a vulnerable sector check with the criminal record check.
- Clear a home safety check to ensure home is a safe environment.

LEVELS OF FOSTER CARE

- Place of Safety
- Alternate home
- Person of Sufficient Interest Home
- Licensed foster home

Who can become a foster parent:

- Any adult with or without biological children.
- You can be single, married, divorced or widowed.
- All applicants must obtain all required information before becoming an approved foster home.
- All foster parents must be willing and able to provide the basic necessities for children in care and work as a member of a professional team.
- You can be employed and daycare/ babysitting services can be provided for children placed in your home.
- A relative of children in care.
- Must be a team player as foster parents will be expected to work with parents in achieving the goal of reuniting the family unit.
- A positive role model in community.
- Live an alcohol and drug free lifestyle.
