Thank you for your help in 2017. Because of this support, we were able to continue advancing our mission through training individuals in our well-being coaching methodology and by forging strategic partnerships in the communities that we serve. The following are some highlights of 2017:

- Our 270-hour Well-Being Coach Certification Program has been accredited by St. Louis University as a certificate program.
- We have collected and analyzed data about our coaching program that demonstrates that participants show significant gains in all aspects of character as measured by the Temperament and Character Inventory.
- We continue to offer annual sessions of our coach training in St. Louis, MO.
- We finished one round of our well-being coach training in Karlskrona, Sweden and began another that will finish in 2018; among the trainees are refugees who will then use the method to serve other refugees.
- Our work at the St. Patrick Center in St. Louis continues, and we have expanded to offer services to Queen of Peace Center as well.
- We continue to make strides in our partnership with the Northwest R1 School District in Jefferson County, Missouri where we are implementing a community-wide well-being initiative.
