

# ACCELERATE OUT OF COURT WORKOUTS

### Challenge

Bankruptcy (Chapter 11) is not an option for any cannabis related business or investor because from a federal perspective, it is breaking the law. No bankruptcy judge will touch any business associated with cannabis. As you can imagine, this creates tension and disputes between creditors and business owners when things go sideways, just as they did for one of Somerset Capital's Colorado clients. After an attempt to file a Chapter 11, a cannabis business was put into a receivership that was not going well. Somerset Capital's team was brought in to help clean things up.

# Transaction Extraction



#### Solution
