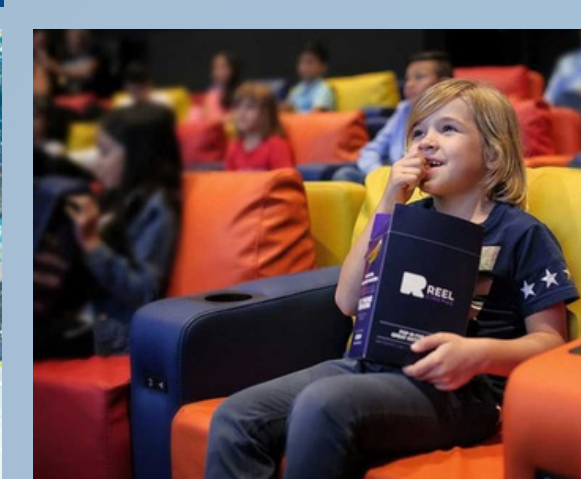

The term “you” and “participants” refers to the customer participating to Our Summer Camp and/or otherwise using our services. The “Parties” refer to “us” and “you”. These terms and conditions in no way invalidate those already on the PSG website.

1.Registration and mandatory documents

1.1.Personal information

1.1.1. All participants are required to review all aspects of their booking to verify - but not limited to - : full names, physical address, email address, telephone number, date of birth, pricing.

1.1.2. Each participant must provide the following documents: Passport copy, emirate ID and documents mentioned in clause 1.3.

1.2.Proof of identity

All participants must be able to present an official written proof of identity at any time and especially during outside trips.

1.3. Insurance and Medical certificate

1.3.1. In case of sporting activity, all players must be insured on the pitch where all members must have a liability insurance.

1.3.2. Each participant must be in possession of the medical certificate for each player. This medical certificate must state precisely that the player is fit for the practice of football/multisport activities in which he/she participates. This certificate may be required by us during the visual inspection.

1.4. Health and travel advice

1.4.1. We advise participants to consult their doctor before making any reservation in order to confirm that it is appropriate for them to participate in our camps and to outside activities.

1.4.2. We will not be liable for any damage arising from an inability to participate in any or all of the events and no compensation will be payable under such circumstances.

2.Acknowledgement and warranties

By enrolling on our Summer Camp each participant:

2.1.Declare that he/she has full parental authority over and bears full responsibility for the Minor and can therefore validly give this consent.

2.2.Confirm that all information/documents that will be provided will be accurate and that he/she is duly aware that he/she could be held liable if he/she makes any false statements.

2.3.Authorises the Minor to:

- take part in the our Summer Camp’s events;
 - travel as necessary for the events (car and/or bus trips between sites);
 - take part in the various activities proposed in connection with the Summer Camp;
- 2.4.Declare that he/she will arrange and pay for the Minor’s activities and all other incurred expenses.

2.5.Accept that the we will provide instructions and guidance to the Minor from the time at which he/she arrives in the Camp/outside sites and until he/she leaves the outside-sites/ the Camp.

2.6.Furthermore:

- certify that he/she has been duly informed of the general terms & conditions and rules applicable at our Academy and that the Minor agrees to abide by them;
- vouch that the Minor will also follow any instructions given by our staff;
- shall pay for any wilful damage committed by the Minor at any time.

2.7.Confirm that he/she has taken out all necessary insurance for the Minor in connection with our Summer Camp’s events, covering in particular public liability, travel, theft, accidents, medical repatriation, etc.

2.8.Certify that we have duly:

- informed each participant that it does not provide insurance cover for any injuries the Minor may sustain during the our Summer Camp’s Events; and
 - recommended that each participant take out his/her own insurance to cover any injuries the Minor could sustain during our Summer Camp’s Events.
- Waive any and all rights of claim against us and our affiliates. This release applies, in particular, in the event of any accident, injury, theft, damage to personal property or other incidents occurring over the course of our Summer Camp’s Events.

2.9.Expressly authorise us to take all necessary action and decisions in connection with the Minor’s medical care and assistance in the event of any accident if it is unable to reach a relative with parental authority or legal guardian of the Minor by telephone.

2.10.We shall promptly inform the parent or legal guardian if the Minor is hospitalised.

2.11.Declare that he/she has informed us of any medical particularities concerning the minor as follows:

- 2.11.1. Allergies;
- 2.11.2. Intolerance to foods or medication;
- 2.11.3. Asthmatic, pain, difficulty to breath during certain types of physical activity.

3.Payments

4.Cancellations

4.1.Any notice of cancellation must be made by email with acknowledgement of receipt to the following email address: admin@psg-academyuae.com. However, it is to be noted that no refunds will be granted.

4.2.Refund policy

4.2.1. It is to be noted that we are under no obligation to return the amount paid by you if the summer camps are cancelled due to reasons attributed to you or for reasons beyond our control.

4.2.2. You can be refunded on a pro-rata basis based on the normal rate (not discounted rates) only for a medical reason making it impossible to practice any kind of sport. The above-mentioned must be dully justified by any documents that we will require.

4.2.3. It is to be noted that each service provider, with whom we are working to organise the Summer Camp events, has its own refund and cancellation policy, as a result of which we adhere to the same.

5.Amendments

We reserve the right to reschedule or cancel a session, at any time, whether in terms of time or location, by sending you a notice to that effect by any means of telecommunication which can be emails, WhatsApp, including our social media platforms. In this instance, we will provide an alternative session at no charge.

6.Code of conduct

6.1.The safety and well-being of all participants attending the Summer Camp are of the utmost importance.

6.2.Consequently, we reserve the right to refuse access to any event of the Summer Camp for any participant who is found to be engaged in an offensive activity, the bullying of others, disruptive behaviour or for any other reason we consider that a participant fails to comply with basic safety rules or standards of good conduct.

6.3.Each participant accepts that we can take all necessary steps if the Minor fails to comply with basic safety rules or standards of good conduct during the Events, and that the parent/legal guardian will be financially and legally liable for the Minor’s actions and be required to pay for the Minor’s return travel home.

6.4.In this case, for any of the above-mentioned reasons, they will be no refund of fees and each participant undertake not to pursue any legal action against us or our affiliates or to claim the reimbursement of any expenses incurred in the event that the Minor is sent home for failing to comply with the standards of good conduct.

7.4. Disclaimers and limitation of liability

We are not liable - whether based on a theory of negligence, contract, tort, strict liability, or otherwise, and even if we have been advised of the possibility of such damages - for the acts, errors, omissions, representations, warranties, breaches or negligence of any such suppliers or for any personal injuries, death, property damage, or other damages or expenses resulting therefrom.

7.4.2. We have no liability and will make no refund in the event of any delay, cancellation, overbooking, strike, force majeure or other causes beyond our control, and we have no responsibility for any additional expense, omissions, delays, re-routing or acts of any government or authority.

7.4.3. You may not assign your rights or obligations under this Agreement to any third party.

8. Severance

If any provision of these Terms & Conditions (or part of any provision) is or becomes illegal, invalid or unenforceable, the legality, validity and enforceability of any other provision of these Terms & Conditions shall not be affected.

9. No Partnership or Agency
