

OA-RX FOR ELECTRONIC PRESCRIBING

This Data Sheet is effective as of April 2023.

This Data Sheet describes the OA-Rx for Electronic Prescribing module, a web-based e-prescribing solution, provided by Office Ally, Inc. ("Office Ally") to the user named on an applicable Order Form (the "User").

1. USE OF SERVICE

The OA-Rx module enables User to:

- Create, electronically transmit, or print prescriptions;
- Reply to renewal requests;
- View formulary alternatives;
- Identify drug and allergy interactions; and
- View patient eligibility for prescription benefits.

An added available feature of the OA-Rx module is the prescriber's ability to send prescriptions for scheduled medications electronically to pharmacies in a certified, safe and secure manner.

2. SERVICE REQUIREMENTS

In order to access and use the OA-Rx module, User must have an active account with Practice Mate and/or EHR 24/7 currently enabled.

3. FEES

The OA-Rx service is free of charge from Office Ally but subject to third party costs. Prescribing Controlled Substances requires multi-factor authentication. The cost of a multi factor subscription is not included and the price of said subscription may vary depending on Office Ally's multi-factor subscription partner.

4. SYSTEM & SECURITY REQUIREMENTS

Office Ally's products and services are internet-based programs accessed through the Office Ally website. For optimal performance users should be in compliance with Office Ally's System Requirements and Recommendations available here: https://cms.officeally.com/formsmanuals.

These system requirements are subject to change. User designates Office Ally to manage security controls using industry standards and HIPAA best practices to include but not limited to: unique user ids, password complexity, minimum password length, limiting password reuse, lock-out parameters, banner notification and password expiration notice. For intended use of the Virtual Visits product, User should utilize a device with tested and reliable video and microphone capability.
