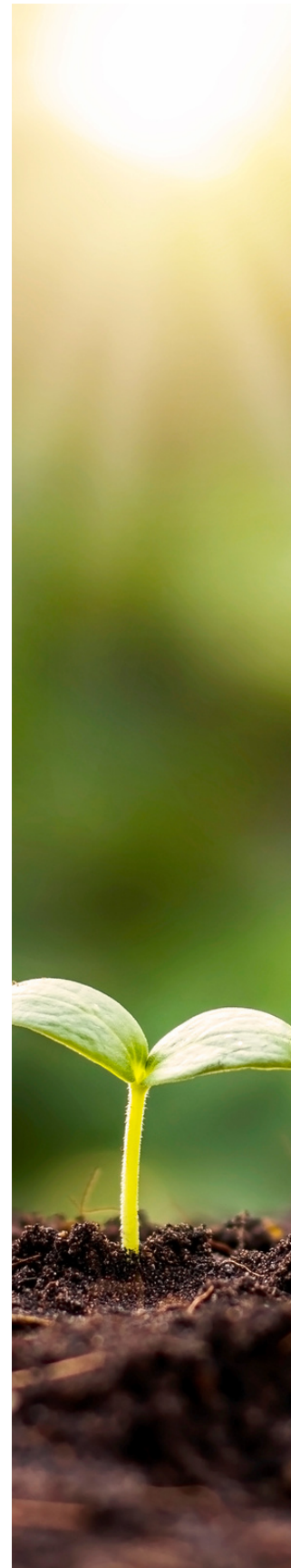

NOTEWORTHY Q1 ACCOMPLISHMENTS

These efforts would not be possible without the support and trust of our partners!

Continued supporting nonprofit organizations in their solar journey with our Solar Moonshot Program, thanks to our generous funders and partners

Successfully helped 3 solar projects go live serving nonprofits in Oceanside's Communities of Concern in partnership with Preserve Calavera and BQuest Foundation. Collectively these systems will save the nonprofits \$2 million.

Helped advance 2 more California Electric Vehicle Infrastructure Project (CALEVIP) rebate applications and projects for nonprofits serving Communities of Concern

Worked with coalition partners to launch a new San Diego effort to help Communities of Concern impacted by January floods rebuild their homes sustainably and efficiently.

Registered support for 8 bills in the California State Legislature to help advance clean energy and climate justice

Assisted the Sherman Heights Community Center in advancing a solar and storage project, which will increase clean energy literacy, resiliency, lower energy costs as well as improve the indoor and outdoor air quality. The Center will soon be a resilience hub for the communities of concern that it serves.

SOLAR MOONSHOT PROGRAM



We are in the fifth year of managing the [Solar Moonshot Program](#), which helps nonprofit organizations switch to clean solar energy, providing much-needed funding for projects that would not have otherwise been built. Thus far, the Solar Moonshot Program has assisted 148 organizations across 28 United States, Puerto Rico and Rwanda, deploying 217,330.70 kW of solar and offsetting 5,416,810.5 metric tons of carbon dioxide. This is the equivalent of the amount of greenhouse gas from 13,438,259,919 miles driven by an average passenger vehicle, carbon dioxide emissions from 5,969,428,415 pounds of coal burned and carbon sequestered from 89,543,658 urban tree seedlings grown for 10 years. We are grateful to the generous funders of this program.

Quarter 1 2024 Metrics and Grantees

- 13 projects (3 completed, 10 in progress) across 8 states and our first international grant for a solar project in Rwanda was committed!
- \$530,702 out of \$1,000,000 committed to the program

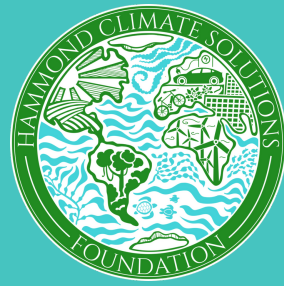

LOOKING AHEAD



Continue Strong Climate Advocacy

We are using our voices and resources to advocate for climate justice locally and statewide. We are continuing to track new climate bills in the California Assembly and Senate and have registered support for 8 bills that help advance clean energy access, remove barriers to adopting clean energy, hold the California Public Utilities Commission (CPUC) accountable, lessen utility influence and stop the abuse of ratepayer funds. We are continuing to push to advance a philanthropic loan guarantee concept for the Solar on Multifamily Affordable Housing (SOMAH) Program through a CPUC proceeding.

Launch a local program to help San Diegans rebuild green

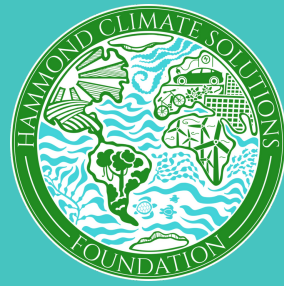
We are working with coalition partners to create a new local initiative to help Communities of Concern in San Diego who were severely affected by the January flooding events. Recognizing the need to rebuild, our coalition partners and HCSF want to help community members rebuild green, with more resilient infrastructure. This effort includes securing funding for the program, working with the city and the county to remove permitting fees and barriers as well as educating community members about this effort and available resources.

Assist with the Power San Diego campaign

We are assisting with the Power San Diego ballot initiative, which is an initiative to municipalize San Diego's utility system. While the campaign team works on gathering signatures to qualify this measure to be on the November ballot, we have helped with organizing press conferences and contacting the media in order to increase public awareness.

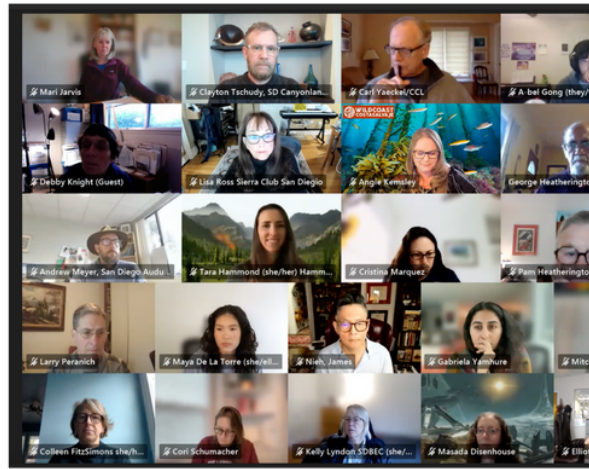
Secure Funding for HCSF and Climate Programs
