Governing Board Meeting

The Governing Board meeting, including board members, delegates, and the public, was called to order at 1:32 pm.

Welcome & Introductions

Thuy Hua-Ly welcomed everyone, and Jeff Sakuma reviewed the agenda.

Board Business

Approval of the Minutes from January 12, 2023

The board reviewed and approved the January 12th meeting minutes unanimously.

Executive's Report

Thuy Hua-Ly reviewed the CEO report. See page 6 of the pre-read packet for details. Thuy's highlights included:

- Highlight Black History Month
- King County Health Disparities Dashboard which highlights the diabetic mortality rate for African Americans living in King County
- We have launched HealthierHere 2.0 website. We hope the new branding will help us engage with our funders and community partners.
- Our work with Care Connect providing care coordination services for people diagnosed with COVID-19 continues to be a heavy lift. This work is supported by a grant from the WA State Department of Health.

CEO Recruitment Update

Jeff Sakuma provided a brief update on the CEO Recruitment. Jeff's highlights included:

- We are continuing to work with Carlson & Beck firm
- We have narrowed the candidate pool and have done and initial interviews. We will be doing a second round of interviews to bring forward 1-2 candidates.
- We will have the candidate(s) meet with the staff as well as the Board and get feedback to make a final decision.

Equity Moment

Jeff Foti shared the meeting equity moment. Jeff spoke about the publicly addressed concern about over policing especially over policing with people of color at Seattle Children's. This resulted in disproportionate calls where security and or potential police was called on people of color. Jeff explained that the Center for Health Equity developed a process of working with administration and community members to resolve the issue. It is on a trajectory for meaningful change.

Dear Governing Board Members,

Spring is just around the corner, and I hope you all are looking forward to the coming blooms in your communities, both literal and figurative. I sure am excited to see the splashes of color in my garden and neighborhood. We also have many big things getting ready to blossom at HealthierHere in the coming months!

In March, we recognize Women's History Month, which has the 2023 theme "Celebrating Women Who Tell Our Stories." Additionally, March 8th is International Women's Day. We celebrate the many diverse, passionate women across our staff, governing board, and network who have collaboratively led and advanced our systems transformation vision and work since day one.

In the face of ongoing systemic attacks on women's bodily autonomy and rights, such as the federal reversal of Roe v. Wade, we will continue to steadfastly support safe and full access to comprehensive health care for all women and girls. Even in Washington State where abortion is legal and protected, women's health and access to reproductive care remain pressing issues.

For instance, in King County, pregnancy and birth complications comprise six of the top 10 leading causes of hospitalization among women. For women of color, these types of disparities are often compounded by chronic stressors due to generational and lived experiences of discrimination and

systemic racism. We see this illustrated in statistics like infants born to Black mothers dying before their first birthday at twice the rate of infants born to white mothers.²

Additionally, the nationwide wave of anti-LGBTQ+ legislation has now reached Washington State with the introduction of House Bill 1214, which would ban all gender-affirming care for minors. This is a serious threat to the safety and dignity of transgender girls and youth in King County, who already face barriers to accessing care, which research shows contributes to higher rates of suicidal ideation/attempts as compared to their peers.³

Together, we uplift the voices of the women and girls across King County to tell a story of strength, innovation, and collective action to transform our systems and improve the health of our communities for generations to come.

In March, our Governing Board will convene in person for the first time in three years! Some of you will reconnect face-to-face after much time apart, and others will meet in person for the first time. I encourage you to bring a spirit of curiosity and camaraderie to this new (but distantly familiar) way of being together!

Similarly, HealthierHere's staff will begin monthly in-person meetings in March to help deepen relationships, build our organizational culture, and move our work forward.

Across the organization, we are prioritizing our work given the current staff vacancies and recruitments underway. This prioritization process will support our team to sustainably focus on key workstreams that help meet the needs of our communities and advance HealthierHere's strategic goals.

Our communications team is developing a 2023 communications plan to help raise the visibility of HealthierHere and our partners locally and nationally, also in support of our 2023 strategic goals.

We are continuing to operationalize the Care Connect program while navigating challenges with a high volume of household financial assistance requests and grocery orders. The Care Connect team has updated the grocery order form to offer culturally appropriate substitutions, which has been well received by clients and Care Coordinators. As of February 15, all four Care Coordination Agencies (CCAs) in contract with HealthierHere have hired and onboarded staff and are actively serving clients. We are hearing from individuals and families about the positive impacts the program is having on their lives, and we look forward to sharing early results from the program with you in the coming months.

The Connect2 Community Network (C2CN) is excited about the work coming this year. We are working to build the technology infrastructure we have co-designed with network partners and are preparing for a soft launch with our initial integration partners soon. This is a big milestone for C2CN and is the next step to achieving the network's vision of creating a connected system of whole-person care.

More on Community Information Exchange (CIE), we are preparing to say a fond farewell to Lisa Watanabe (Project Manager, CIE) who will be retiring this summer. I send a heartfelt thank you to Lisa for all that she has helped HealthierHere to accomplish. We will carry the torch to ensure the continued success of the CIE – she will always be a part of its legacy. Join me in wishing Lisa many more joyous moments and memories in her next adventures!

Finally, HealthierHere is continuing its partnership with the Healthcare Industry Leadership Table this year to help build a skilled, diverse, and culturally competent healthcare workforce. Some of our staff will be volunteering at the <u>Sound Careers in Healthcare</u> event on March 21, which is designed for high-school-age youth who identify as BIPOC, low-income, and/or first-generation English learners interested in exploring education paths to careers in healthcare.
