CEO Report

John Kim referred to the CEO report in the pre-read packet. John expressed gratitude to Board member Semra Riddle, last minute HealthierHere was tapped to serve as a moderator for Senator Cantwell at the fourth Fentanyl listening session.

Time was given to Semra Riddle to share her thoughts on the experience.

Equity Moment

Junson Hu shared the meeting equity moment. Junson wanted to start his equity moment with an experience he had at a clinic. Junson explained he met a parent who was not able to cover vaccination for their child. The family was offered the Childhood Vaccine Program which covers all vaccination for children under the age of 19 yrs old. Junson expressed his gratitude in being able to see first hand how the advancement of childhood vaccination has advanced and felt grateful to be able to have witnessed first-hand this moment.

the charter; and

 Updating language based on recent bylaw changes (e.g., around Officer appointments)

The Executive Committee recommends the updated Executive Committee Charter.

The board unanimously voted to approve the Executive Committee Charter.

- Performance based contracts: having a pilot of bundle payments for BH
- Concierge medicine; we are able to provide services that normally would not be paid for. Such as wound care, helping someone get new socks, or other necessities that are not currently being met by our current health system.
- Whole person care: relationship building/ outreach, built trust.
- Innovations: Sen. Cantwell was looking for these types of innovations mentioned at this meeting

September 2023 Chief Executive Officer Report

Dear Governing Board Members,

I hope you all have been enjoying the gifts of summertime in the Pacific Northwest.

On September 7th, we will come together for our first in-person governing board meeting in over three years. I look forward to seeing you all for this celebration of the people and relationships that make HealthierHere so vibrant and uniquely positioned to create change as a cross-sector convener. Certain near-term realities are starting to come into focus that will require changes to our staffing and infrastructure needs. We want to meet those needs with an eye toward HealthierHere's mid-range and long-term aspirations and the strategies we will develop to achieve them. In the coming months, we plan to dedicate more time to having generative conversations that will help ensure our mission, vision, and values are still relevant and will continue to be so as we look forward.

We are now embarking on the journey of planning for Medicaid Transformation Project (MTP) 2.0. The coalition of ACHs continues to align our efforts and advocacy with the Health Care Authority as the final terms and conditions of our contract are finalized. Amidst the waiver planning, we must keep our sights set on horizons beyond MTP. It's time to envision all the things HealthierHere can be, and what we can achieve with, by, and for our communities. I am inspired by the collective wisdom of this board. Please bring your insights, expertise, and bold ideas to the table as we chart our path ahead.

Here, I'd like to highlight a variety of initiatives HealthierHere engages in that represent the breadth of our work and capabilities.

Cross-Sector Collaboration

HealthierHere is an active partner in <u>CHW CARE</u>, a three-year cross-sector initiative funded by the <u>Centers for Disease Control and Prevention</u> to **train**, **deploy**, and **engage community health workers (CHW)** in **King County**. HealthierHere serves on workgroups related to communications and data,



drawing on our in-house expertise to inform strategy, co-develop resources, and amplify <u>learnings</u> and <u>successes</u> upstream – with the goal of scaling and sustaining the CHW model in our region and beyond.

Addressing Disparities

From the earliest days of the pandemic, we saw the <u>disproportionate impacts of COVID-19</u> on certain King County communities. As previously shared, HealthierHere implemented Care Connect 1.0 with funding from WA Department of Health to ensure that community members were supported through successful completion of quarantine periods. <u>Read our latest blog post</u> to see stories and highlights from Care Connect 1.0.

Even after the end of the Public Health Emergency, individuals and families continue to face challenges to their well-being and recovery due to the pandemic. In July 2023 HealthierHere's Community Hub launched Care Connect 2.0, again funded by the WA Department of Health. The program supports people in King County impacted by the pandemic – in particular, those struggling to recover from its health, economic, and social effects.

Equity in Process and Effect

For the third year in a row, Healthierhere is offering to members of staff, board, and committees the opportunity to participate in <u>Wrestling with the Truth of Colonization</u>. This training and community organizing initiative developed by the <u>Industrial Areas Foundation</u> focuses on the impacts and history of relationships between dominant society and Indigenous Peoples; it aims to eliminate systemic barriers in current dominant structures by creating conditions that protect and expand Indigenous sovereignty while creating racial equity for all. The learnings, personal reflections, and recommended actions from the initiative continue to inform HealthierHere's work around equity, decolonization, and anti-racism.

As part of HealthierHere's commitment to the process and of effects of equity, we recently launched our Equity Definition and Guidelines Survey, which asks all the bodies of HealthierHere to honestly evaluate HealthierHere's implementation of its equity principles. Honest feedback will allow HealthierHere to understand where our equity strengths are and where our areas of improvement and growth reside. All of the information received in the survey will inform our Equity implementation plans for the organization.

System Transformation

The <u>Connect2 Community Network</u> (C2CN) continues to make progress in bringing together disparate systems to better serve the health and social service needs of our community. After two years of community-centered co-design, planning, and building a Community Information Exchange (CIE) for King County, C2CN conducted its soft launch in the spring, which included publication of its <u>Privacy Policy</u>.

The C2CN technology interface, which is currently in testing, will allow HealthierHere and its <u>contractors</u> <u>under Care Connect</u> to share information collected in Care Coordination Systems (CCS) in order to make bi-directional referrals beyond the boundaries of the Care Connect program.

HealthierHere Internal Operations

With growing staff and the need for more in-person interactions, HealthierHere is making plans to return to a dedicated office space. We are engaging with all staff members to understand and address their needs and visions to collaboratively plan for this transition. Finance & Audit Committee Charter

New Charter Approved: August 2023 Original Charter: January 2018

Purpose

The Finance & Audit Committee supports HealthierHere in fulfilling its fiduciary responsibilities for both the LLC and 501C3 entities, including budgeting, financial modelling, monitoring budget vs. actual, financial reporting, contracting and audit.

The Finance & Audit Committee is responsible for fiscal oversight related to:

- The internal operations of HealthierHere such as the administrative budget;
- B. The financial analysis to support a fully functioning C3 organization;
- C. The MTP 2.0 Renewal Waiver;
- D. HealthierHere's annual audit;
- E. Ad-hoc financial analysis in support to the Governing Board and its committees, as needed; and
- F. The development of HealthierHere's investment policy for approval by the Executive Committee and Governing Board, followed by ongoing oversight of investments.

Guiding Principles

The Finance & Audit Committee will operate under the broad HealthierHere principles including equity, community voice, mutual respect, and transparency and will work with other committees as appropriate to mitigate decisions made in silos that could have financial impacts to HealthierHere or its partnering providers. Specific additional principles for this workgroup include:

Eliminate disparities: Work intentionally to ensure that all people can access the same opportunities for health and experience similar outcomes by eliminating racial, ethnic, socio-economic and geographic

disparities in health and well-being. Look at who decides, who provides, and who benefits from or bears the burden of our actions.

Fiduciary Responsibility: Always act in the best interest of the community HealthierHere serves, not our personal or organizational self-interests. Operate with the highest legal and ethical standards.

Generally Accepted Accounting Principles (GAAP): Ensure the ACH's financial operations, processes and reporting follow this industry standard and best practice.

Accountability: Responsible to perform duties required of this workgroup to further the goals of HealthierHere.

Transparency: Open communication of information and process and not focus on sector's agenda but rather focus on the overall transformation goals

Collaboration: Members work together to achieve HealthierHere's goals and objectives

Value-Driven: Seek to meet the state's definition for Triple Aim of better health, better care, and lower costs.

Flexibility: Being open to innovative ideas and explore possibilities with pragmatism

Responsibilities

Internal Operations

- Review and recommend to the Governing Board HealthierHere's annual budget
- Oversee the development of the organization's budgeting, financial monitoring, internal control processes, and financial policies and procedures
- Review and approve financial reports
- Ensure adequate protection of HealthierHere's assets
- Develop and oversee HealthierHere's investment policy

External Operations - Including Delivery System Reform Incentive Payment (DSRIP), Value Based Payments, and Other Funds:

- Oversee the distribution of funds to partnering providers
- Oversee the distribution of funds to investment priorities agreed to by HealthierHere's Governing Board
- Monitor HealthierHere in meeting requirements outlined in state, provider, and other transformation project contracts

Confidentiality

 Ensure confidentiality of discussions until final recommendations and/or decisions are ready to be communicated

Timeline / Meeting Frequency

The Finance & Audit Committee is a standing committee that meets at least quarterly. It may decide to add, cancel, or modify meetings as appropriate. To constitute a "quorum", at least 60% of all members of the Finance & Audit Committee must be (physically or electronically) present. The preferred meeting mode is in-person though members may call in, if necessary.

Each member of the Finance & Audit Committee will act as a fiduciary for HealthierHere, rather than a representative of his or her sector. Further, all members of the Finance & Audit Committee must attend at least 75% of all regular and special meetings held during each calendar year, unless the absence is excused for good cause, as determined by the Committee Co-Chairs. Failure to meet the attendance requirements will lead to potential removal of the member.

Decision Making Process

The Finance & Audit Committee aims for consensus but relies on a simple majority vote for final decision-making. Key decisions will be made in person at Finance & Audit Committee meetings. Members will be provided with adequate advanced notice about decision items. For more routine items, decision making may be conducted over email and/or phone.

The Treasurer, who also serves as one of the Co-Chairs of the Finance & Audit Committee, will coordinate and ensure communication of key activities or issues with the Executive Committee.

Reporting

The Finance & Audit Committee will provide regular updates to HealthierHere's Governing Board. Agenda and meeting materials will be distributed at least 3 business days in advance, and will, whenever possible/appropriate, be available to the public online. Decisions will be documented in meeting summaries.

Membership and Terms

Membership will include individuals representing sectors critical to the project success and the terms for the members will align with their terms on the Governing Board, if applicable. The committee reserves the right to designate/appoint additional non-board members as needed based on the need for specific subject matter expertise. The committee will specify the duration of this appointment.

Finance & Audit Committee members will select the Co-Chairs of the Finance & Audit Committee. Replacement of a vacating board member will be prioritized by the sector represented by that board member. Nominees will be reviewed by the Finance Co-Chairs/Treasurer, and HH's CFOO and the recommendation will be presented to the Finance & Audit Committee for approval.

HealthierHere's CFOO will maintain a detailed list of board member terms and alert the Finance & Audit Committee when actions are needed.

Conflicts of Interest

Finance & Audit Committee members are required to comply with HealthierHere's Conflict of Interest Policy.
