2022 - NTHM

The following resolutions were approved at the last Native Title Holders meeting.

- Alliance Mineral Assets Ltd
The Native Title holders resolved to carry the proposed Land Access Agreement with Alliance Mineral Assets Ltd which includes State deeds for the grant of M15/1840 and M15/1851, and to withdraw objections to miscellaneous licence applications L15/380 and L15/425.
- Fortescue Future Industries Pty Ltd
FFI's proposal to carry out a renewable energy project on parts of the Ngadju determination area was also endorsed. The Framework provides access being granted to begin preliminary investigations for this project, mainly wind power testing and light ground testing.
- Travel Policy
Ngadju People native title holders resolved that Native title holders who live outside the town/city where the meeting is held may be eligible for travel allowance to help cover their costs of travelling to the meeting in accordance with travel reimbursement procedures. The driver for this policy is to promote inclusivity for all members.



Ngadju Businesses

Throughout 2022 we have continued to work with our business partners to promote engagement of Ngadju Member businesses to assist and provide services to these companies.

We have included clauses within our agreements and contracts that Ngadju businesses are to be supported as an integral element of the partnership.

With the current increase in exploration and mining activity on Ngadju country, there are a number of job opportunities available. We are planning to include a directory of business section as part of our website, where proponents would be able to advertise job opportunities and Ngadju members could advertise their services.

Cultural awareness training is also being offered to mining proponent with 8 entities already showing interest.

Since our last newsletter there has been a number of projects commence and negotiations continue for a number new project developments.



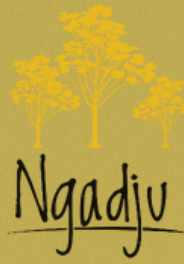
We have finalised and executed 29 new Heritage Agreements for the Ngadju community.

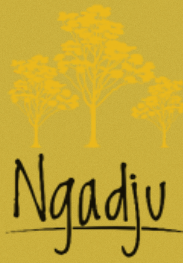
