Personal Data We Collect and Process

Antonio Media B.V. processes your personal data when you use our services or provide it to us. Below is an overview of the personal data we process:

- First and last name
- Address information
- Phone number
- Email address
- IP address

- Bank account number

We collect this data through:

- Filling out our contact form on our website
- Emailing or calling us
- Other forms of contact
- Completing our questionnaire
- Applying via email

Special and/ or Sensitive Personal Data We Process

In the case of job applications, Antonio Media B.V. collects and processes the following special and/or sensitive personal data:

- Health information: to consider special situations where direct contact with a doctor may be necessary.
- Citizen Service Number (BSN): for tax purposes.

Purpose and Legal Basis for Processing Personal Data

Antonio Media B.V. processes your personal data for the following purposes:

- To contact you by phone or email if necessary to provide our services.
- For the preparation of a quote, agreement, or employment contract.
- Antonio Media B.V. also processes personal data when required by law, such as data needed for tax filing.

Online Questionnaire

To improve the websites, webshops, or apps of our clients, we use an online questionnaire. We only collect the information you provide, keep it securely, and do not share it with others. All results are processed anonymously and shared anonymously with the client for whom we conduct the research.

Automated Decision-Making

Antonio Media B.V. does not make decisions with significant consequences for individuals based on automated processing. This involves decisions made by computer programs or systems without human involvement.

Retention of Personal Data

Antonio Media B.V. does not retain your personal data longer than necessary to achieve the purposes for which it is collected. We have a retention period of 7 years. For rejected job applications, we have a retention period of 4 weeks.

Sharing Personal Data with Third Parties

Antonio Media B.V. does not sell your data to third parties and only discloses it if necessary for the execution of our agreement with you or to comply with a legal obligation. We enter into a data processing agreement with companies that process your data on our behalf within the European Union, ensuring the same

level of security and confidentiality of your data. These parties use your data only in accordance with our instructions and not for their own purposes. Antonio Media B.V. remains responsible for these processing activities. For certain tasks, we use third-party tools such as Google Analytics and MailChimp. These are not 'third-party recipients' but processors.

Cookies

Antonio Media B.V. uses only technical, functional, and analytical cookies that do not infringe on your privacy. Like any professional site, our site requires cookies to operate. A cookie is a small text file stored on your computer, tablet, or smartphone when you first visit this website. The cookies we use are necessary for the technical operation of the website and your ease of use. They ensure the proper functioning of the website and remember your preferences. Additionally, they help us optimise our website. You can opt out of cookies by configuring your internet browser not to store cookies. You can also delete all previously stored information through your browser settings.

Your Rights: Access, Correction, Deletion

You have the right to access, correct, or delete your personal data. You also have the right to withdraw your consent for data processing or object to the processing of your personal data by Antonio Media B.V., as well as the right to data portability. This means you can request us to send the personal data we hold about you in a computer file to you or another organisation of your choice. To exercise these rights, send a request to contact@antoniomedia.com. To ensure that the request for access is made by you, we ask you to include a copy of your ID with the request. Please black out your photo, MRZ (machine-readable zone, the strip with numbers at the bottom of the passport), passport number, and Citizen Service Number (BSN) for privacy protection. We will respond as soon as possible, but within four weeks, to your request.

Security of Personal Data

In addition to legal requirements, Antonio Media B.V. takes the protection of your data seriously and implements appropriate measures to prevent misuse, loss, unauthorised access, unwanted disclosure, and unauthorised alteration. We limit access to data to individuals who need it, have our employees sign confidentiality agreements, and create backups of the data.
