

Privacy Policy for the Website [HTTPS://WWW.TORBA-BORBA.COM](https://www.torba-borba.com)

1. For the owner of this website, the protection of users' personal data is of the utmost importance. Every effort is made to ensure that users feel secure when entrusting their personal information while using the website.
2. A user is an individual, legal entity, or organizational unit without legal personality, which the law grants legal capacity, using electronic services available on the website.
3. This privacy policy explains the principles and scope of processing user's personal data, their rights, as well as the obligations of the data controller and provides information about the use of cookies.
4. The administrator employs state-of-the-art technical and organizational measures to ensure a high level of protection for processed personal data and to safeguard against unauthorized access.

I. PERSONAL DATA CONTROLLER

The administrator of personal data is: DESIGN TEAM SPÓŁKA Z OGRANICZONĄ ODPOWIEDZIALNOŚCIĄ with its registered office at: UL. FRANCISZKAŃSKA 7/1 1, WARSZAWA 00-233 registered in the business register kept by the District Court in WARSZAWA, Economic Department, under the number KRS: 0000843078, NIP: 5252824045 (hereinafter referred to as the "Owner").

II. PURPOSE OF PROCESSING PERSONAL DATA

1. The administrator processes the user's personal data for the purpose of handling orders placed through the form available on the website <https://www.torba-borba.com/order>.
2. Users may also give consent to receive information about news and promotions, resulting in the administrator processing personal data for the purpose of sending commercial information, including new products or services, promotions, or sales.
3. Personal data is also processed to fulfill legal obligations imposed on the data controller and to perform tasks in the public interest, such as tasks related to security and defense or the storage of tax documentation.
4. Personal data may also be processed for direct marketing of products, securing and pursuing claims, or protecting against claims from the user or third parties, as well as marketing third-party services and products or own marketing not constituting direct marketing.

III. TYPES OF DATA

1. The administrator processes the following personal data necessary to confirm the order:
 - email address;
 - country.

IV. USER RIGHTS

1. Users can request information from the administrator about the scope of processing their personal data at any time.
2. Users can request correction or rectification of their personal data at any time.
3. Users can withdraw their consent to the processing of their personal data at any time without stating a reason. Withdrawal of consent will result in the deletion of the user's account and all previously processed personal data by the administrator.
4. Users can request, without giving a reason, the deletion of their data at any time. The deletion of data implies the simultaneous deletion of the user's account, along with all personal data previously processed by the administrator.

5. Users can object to the processing of personal data at any time, both in the scope of all processed data and only to a limited extent, e.g., regarding processing for a specific purpose.
6. Users can request restrictions on the processing of personal data, either for a specific period or without time limits but in a specific scope.
7. Users can request the transfer of their processed personal data to another entity. Confirmation of the user's request is necessary for security reasons and to ensure that the request comes from an authorized person.
8. The administrator will inform the user about the actions taken within one month of receiving any of the requests mentioned above.

V. DATA PROCESSING BY OTHER ENTITIES

1. The administrator may entrust the processing of personal data to entities cooperating with the administrator, to the extent necessary for transaction fulfillment, such as preparing ordered goods and delivering parcels or sending commercial information.
2. Personal data of website users will not be shared with third parties or transmitted to other entities for the purpose of sending marketing materials from these third parties.
3. Personal data of website users is not transferred outside the European Union.
4. This Privacy Policy complies with the provisions of Article 13(1) and (2) of the GDPR.
