## 2022 OFFICIAL RULES

To enter the Sweepstakes, you must (i) go to (www.edgarsnyder.com/steelers), (ii) follow the instructions to complete the online entry form during any week of the Promotion Period; (iii) click on the "donation" mechanism; and (iv) provide a donation to The Heyward House/The Ryan Shazier Fund for Spinal Rehabilitation (the "Donation Entry"). Those eligible individuals submitting a completed Donation Entry (the "Entrants") agree to be bound by the terms and conditions of these Rules, and will be entered into a random weekly prize drawing during the Promotion Period and the grand prize drawing to be held by Sponsor after the Promotion Period (each, a "Drawing"). PRIZES: There will be a total of twenty (20) Prizes awarded. There will be one (1) Prize awarded during each of the twenty (20) weekly Drawings. The Prize Winners shall receive either (a) one Pittsburgh Steelers autographed authentic football (ARV \$300); (b) one Pittsburgh Steelers autographed authentic helmet (ARV \$500); or (c) one Pittsburgh Steelers autographed authentic jersey (ARV \$500). Each weekly Prize will be autographed by a current player of the Pittsburgh Steelers, who will be determined in the Steelers' sole and absolute discretion. GRAND PRIZE WINNER: One (1) grand Prize Winner ("Grand Prize Winner") will be chosen approximately three (3) days following the final Steelers regular season or playoff game of the 2022 NFL season, at random from the pool of Entrants who have completed the required steps as of the end of the Promotion Period.
