"I am excited to lead BFT into its next phase of growth, building the foremost natural fibre innovator and manufacturer for the global nonwoven and specialty textile markets," says Mr. Posa. "The world is urgently seeking solutions to plastics pollution and BFT's tree-free and plastic-free, natural plant fibres will play a key role in the movement away from single use plastics."
