Terms and Conditions

General Terms

These General Terms and travel regulations are a component part of the Agreement between Real Tours, LLC, (dba TrulyCroatia Tours), (hereinafter: the Agency) and the travel contractor (hereinafter: the Traveler). All the information and terms in the program and these General Terms are binding for both the Agency and the Traveler.

Offers

The Agency ensures services according to the information published and valid at the time of the reservation confirmation, and according to the description and travel period in accordance with confirmed reservations except in circumstances beyond our control which cannot be foreseen nor eliminated (natural disaster such as earthquakes, floods, sanitary disruptions, fires, droughts, wars, strike, terrorist action and limitations issued by the government mobilization, country exit ban).

Reservations and Payment

Inquiries and accommodation reservations can be made via e-mail, as well as at the office of our partner travel agencies. By confirming a reservation, the Traveler confirms that he or she has read these General Terms and Conditions of the travel services and fully comprehends and accepts these terms which are binding for both the Traveler and the Agency.

The Agency provides the Traveler with the appropriate materials in electronic form, presenting all relevant information regarding the trip, and provides or points out the general terms and conditions of the trip which are an integral part of this Agreement, as well as offers of travel insurance package. The Traveler is obligated to provide any information required for the reservation process.

A deposit is required depending on the chosen payment method. The balance payment is due at least 60 days before arrival unless otherwise specified upon booking confirmation. All prices and payments will be shown in EUR or USD equivalent.

The payers and recipients bank transfer fees are covered entirely by the client. The amount your credit card account will be charged for is obtained through the conversion of the price in USD or Foreign currency. When charging your credit card, the same amount is converted into your local currency according to the exchange rate of credit card associations. As a result of this conversion there is a possibility of a slight difference from the original price stated on our website.

Sojourn Tax

According to the Law on sojourn tax of the Republic of Croatia, the Traveler is obligated to pay the sojourn tax along with his/her accommodation payment. According to the Law on sojourn tax of the Republic of Croatia, the sojourn tax is from €1.33 per person per day for adults and is collected by accommodation providers on your behalf.

Adolescents from the age of 12 to 18 (but not after they turned 18) are entitled to 50% discount, while children under the age of 12 are exempted from paying the sojourn tax. The total amount of the sojourn tax for a specific reservation is determined by the destination in the Republic of Croatia as well as the accommodation service dates.

The final tour price that you pay includes all taxes and fees for transportation, hotel occupancy and other travel related services.

Price Guarantee

Prices in our brochure and website are based on costs and exchange rates. All prices are quoted in EUR on website. No surcharge in respect of costs or currency fluctuations will be made within 30 days of the commencement of the land content of any holiday or once payment of the deposit of your land tour has been received. The price of your travel arrangements can be varied due to changes in transportation costs such as fuel, scheduled airfares and any other airline cost changes which are part of the contract between airlines (and their agents) and the tour operator or organizer. The price of your travel arrangements can also be varied due to government action such as changes in VAT or any other government imposed changes and currency changes in relation to an exchange rate variation. **In the case of any small variation, an amount equivalent to 2% of the price of your travel arrangements, which excludes any amendment charges, will be absorbed or retained. For larger variations, this 2% will still be absorbed for increases but not retained from refunds. Variations greater than 2% will not be absorbed and final tour price will be adjusted accordingly. In either case, there will be an administration charge 1% per person together with an amount to cover agents' commission.**

Cancellation & Refund

TrulyCroatia Tours reserves the right, in its sole discretion, to reject an individual at any time prior to departure, or to cancel the tour in which a traveler is scheduled to participate. In the unlikely event of such a cancellation by TrulyCroatia Tours, or if a traveler has been rejected, the total amount paid to TrulyCroatia Tours (less airfare) will be refunded, unless the cancellation is due to non-payment of the trip deposit and any subsequent payments of the tour price by the final payment due date. Other than such a refund, TrulyCroatia Tours will not be responsible to a traveler for any other refund, costs, interest, liability or damages of any kind.

If traveler cancels for any reason, he or she must notify TrulyCroatia Tours in writing. The cancellation will be effective upon our receipt of the written notification via

email at info@trulycroatia.com. TrulyCroatia Tours incurs substantial administrative and planning costs prior to the departure of traveler. Therefore, regrettably, if traveler cancels his or her participation in the program, funds paid by traveler to TrulyCroatia Tours can be refunded only as set forth below.

The deposit is not refundable for any reason.

If the cancellation is effective:

- 61 days or more prior to the scheduled start date, the deposit is non-refundable, and any additional payments for the tour will be refunded, and the balance, not including any applicable airline cancellation penalties, will be refunded;
- 60 to 45 days prior to the scheduled start date, the deposit is non-refundable and any payments for the tour up to 50% will be retained, and the balance, not including any applicable airline cancellation penalties, will be refunded;
- 44 to 31 days prior to the scheduled start date, the deposit is non-refundable and any payments for the tour up to 75% will be retained, and the balance, not including any applicable airline cancellation penalties, will be refunded;
- 30 or fewer days prior to the scheduled start date, none of the traveler's expenditures on the tour will be refunded.
- **No refunds will be made for unused portions of the tour for any reason.**

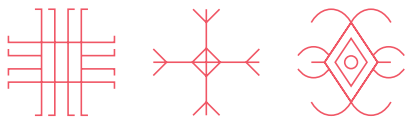

Itinerary Changes

We endeavor to operate the Tour as outlined herein. However, circumstances beyond our control may require an adjustment to the Tour's inclusions. We strive to avoid such changes, but must reserve the right to make such modifications. If Traveler cancels his or her participation in the Tour because of a needed change, normal cancellation penalties will apply.

We must reserve the right to substitute hotels if necessary.

Sharing Rooms

If you cancel your tour and were sharing a room with another tour participant the cost of a single room supplement will be deducted from your refund (if any). If no refund is forthcoming, your tour deposit will be applied to the single room supplement.

Categorization and Service Description

The offered accommodation units are described in accordance with the official categorization of the proper authority, as well as the actual state of the unit at the time of its publication. The standards of accommodation, food, services and like vary depending on the destination and are not subject to comparison. The information provided to the Traveler at the point of sale does not obligate the Agency any more than the information stated on the web pages of www.trulycroatia.com or in the catalog of other printed materials of the Agency.

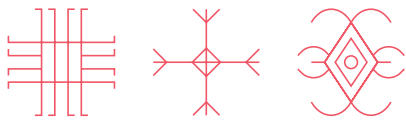
Obligations of the Traveler

The Traveler is obligated to:

- Have valid travel documentation.
- Respect and abide by all customs and foreign exchange regulations of the destination country.
- Respect and abide by all customs and foreign exchange regulations as well as the laws and other regulations of the Republic of Croatia as well as other countries which he/she passes through or resides in. Enquire whether or not he/she require a visa for the destination country as well as neighboring countries. In the event the Traveler is unable to continue the trip as a result of being in direct violation of these regulations, the Traveler is responsible for all related expenses. Abide by house rules of the accommodation unit as well as cooperate with the service providers in a well-intentioned manner.
- Upon arriving at the destination, present the service provider with the document proving the paid service (voucher or tour itinerary equivalent received via e-mail).
- If Traveler does not follow these regulations, he/she will be held responsible for any expenses or damages. By confirming a reservation, the Traveler has agreed to compensate the service provider on the spot for any potential damage caused by he/she own negligence.

Travel Insurance

The cost of the trip does not include the travel insurance „package“: insurance against accidents and illness that may occur during the trip, damage or loss of luggage or voluntary health insurance. Should the Traveler request additional insurance, arrangements can be made with the insurance company. Please review your insurance policies carefully including all exclusions and limitations. Agency is not a licensed insurance broker and it can neither interpret nor advise on the contents of any insurance policy.

Luggage/Personal Effects

The Agency is not responsible for lost, damaged or stolen luggage, nor for stolen luggage or any valuables kept in the accommodation unit (renting a safe is possible or buying and the insurance package which would include luggage insurance is recommended). Lost or stolen luggage should be reported to the accommodation service provider or to the relevant police station.

Photography

Participants on tour may be photographed for the educational and promotional purposes of the Agency. Photographs may be printed in publications and posted on websites to promote the Agency. Travelers who prefer that their image not be used must advise the agency or tour manager at the beginning of the tour.

Passports & Visas

A valid passport is required of all tour participants. It must be valid six months after the date of return.

Non-US citizens must consult with the appropriate consulates to determine if any visas are needed. All passengers, regardless of the passport they hold, should check with the appropriate consulates to determine if any visas are needed. Securing any needed visas is the responsibility of the tour participant.

Gratuities

Customary gratuities to the drivers, tour escort, tour guide, and hotel staff are not included. These gratuities should be extended on a voluntary, individual basis.

Travelers Requiring Special Assistance

Travelers must report any disability requiring special attention at the time a reservation is requested. TrulyCroatia will make reasonable attempts to accommodate the special needs of such Traveler, but does not guarantee this, and is not responsible for any denial

of services by airlines, Croatian carriers, hotels, and other independent suppliers. TrulyCroatia regrets that it cannot provide individual assistance to a Traveler for walking, dining, getting on and off motor coaches, ships and other transportation vehicles, or assist with other personal needs. Travelers who need such assistance must be accompanied by a qualified companion who is also a Traveler in the tour.
