Guest Speaker

- 5. Tauranga Carbon Reduction Group (Paper C) Presentation has been uploaded to the CTWF meetings webpage.
 - Riki Nelson Introduced Glen Crowther.
 - Glen Crowther spoke to the Tauranga Carbon Reduction Group Presentation.
 - Sustainable Bay of Plenty Trust started 2.5 years ago it is independent and struggles financially.
 - Methane emissions have not seen a big increase since 1990, Carbon Dioxide and Nitrous Oxide is increasing more. New Zealand has some of the highest emissions in the world.
 - Three key Strategic Issues:
 - An unsustainable, inequitable "growth agenda"
 - o Lack of informed, open, local, democratic decision-making in Tauranga.
 - Money allocated to 'nice to haves' when we still need 'must haves'.
 - Concerns expressed on the lack of public consultation, e.g. our city hasn't had consultation on a transport plan for Tauranga since 2013. People of Tauranga do not understand what the plan is.

The Chair opened the floor to members for questions or comments.



- Whitiora noted the loss to the moana and local waterways as a result of growth, he asked that this list be more specific to name the rivers that are being taken from for human consumption.
- Pine acknowledged the work done. However, these issues have been raised for a number of years. A realisation is required that it's not about what's in it for us, it's about what's in it for everybody.
- Mokoera asked what is one thing needed to address the issues brought up? What does a "Smart Growth" look like?
- Glen responded that better low carbon transport options for people would help address the issues. The challenge is to determine how people get around first, then provide better options, not road tolls/road pricing. Another area of importance is housing.
- Andy noted that everybody should be benefiting from growth. A complete shift is needed to
 work together and in harmony with the earth, important to ensure everyone is brought
 along on the journey of growth.
- The Chair thanked Glen for his presentation, many of the matters discussed align with our values, beliefs and discussions that are had around this table.
- Buddy as the TSP representative reported that the TSP is currently fragmented and
 therefore not working together. Each area has their own communications strategy causing
 fractured picture of the group. At the last TSP meeting, Buddy asked for all communication
 groups to be combined into one, to allow for a more coordinated approach.

6. SmartGrowth Strategy Session - Presentation has been uploaded to the CTWF meetings webpage.

7.

Elva Conroy provided an overview to the Strategy Session including the topics from the draft SmartGrowth Strategy discussed at the last CTWF Hui.

Transformation shifts – what we are doing differently this time around.

Craig spoke on transformation shifts and the intent being to target the priorities in the strategy:

- 1. Homes for Everyone.
- 2. Marae as Centres and the unlocking of Papakāinga.
- 3. Emissions Reduction through Connected Centres.
- 4. Strong economic corridors linking the East and West to the City and the Port.
- 5. Radical change to the delivery, funding and financing model for growth.
- These priorities will form part of the consultation, with submissions in October.
- Priority 4 has developed further now. It is looking closely at the links between Tauranga, Waikato, Eastern Bay & Rotorua growth, these areas impact our city in regards to the transport links.
- It was noted we are all experiencing a housing crisis, a lag in the number of homes being built in the region. Māori housing is covered in priorities 1 and 2. Will look to weave our CTWF priorities into these transformational shifts. The concerns and issues that have been raised by this forum are being included.
- To capture what came through the forum and previous strategies, Ngā Wai ki Mauao me Maketu from the mountains to the sea. The fundamental Principle provides equal recognition of our people.
 - In regard to the harbour waters and coastal waters using Nga Wai to represent all of the waters.



- This was an opportunity to reflect that there are multiple water principles & values. One
 way to recognise the people, iconic places and be the underlying principle for all the
 transformational shifts in the strategy.
- Ensure we are encompassing all that sit around this table including who and what they represent.
- Trying to put all the issues on the table to determine where we are going to be in 50,
 70, 100 years, using these principles to put forward how to balance the decision around the protection of the people and our own group.
- Challenge for us, it's not just our own back yard, we are looking at our whole subregion. The Chair noted the support in principle, can the Combined Tangata Whenua Forum give full support.
- Where will we be in the future, what is the solution? behaviour, stop relying on the high areas that feed the lakes, our waters come from the top and feed down, coming out at Maketu, but in what condition? Can we look at Capturing our water and storing it on Iwi land?

Future Development Strategy (FDS) – to meet the National Policy Statement (Urban Development).

- Craig spoke to the Future Development Strategy Presentation.
- Move towards greater intensification and less sprawl, 10-year update and review in process now.
- Future Development Strategy (FDS), is a legal requirement for SmartGrowth partners, comes from the National Policy Statement on urban development. 30 Year planning short term, medium and long term reviewed after 3 years. Development capacity for housing, business and infrastructure to support.
- Implementation plan comes after the FDS and is a 3 year plan reviewed every year. No engagement and consultation is required. In SmartGrowth we work with our partners. The FDS and Implementation plan are legally required to be done through the partnership.
- SmartGrowth Strategy and FDS will be going out for consultation later in the year.
- The Chair noted that it was important to look at how we apply what is discussed in this forum to the FDS, it is daunting, it is a work in progress, but we have started and there is still a journey.
- As this journey continues, the more conversation that happens and more information shared will allow the Combined Tangata Whenua Forum to look at the future and what is needed to get there.
- It was noted that in these slides they will help show where each individual fits into the SmartGrowth Implementation Plan feeding into the Tangata Whenua Spatial Plan. An assessment needs to be made on where Tangata Whenua are in regard to Hapu, Marae, Māori landowners. Looking back at nearly 2 years ago the first Hui with Māori Land Trusts, it was asked where they want to be and what they want for their mokopuna.
- The forum has been working from the other end, looking at the strategy working from the core components. Tangata Whenua has started with grassroots, what this presentation is trying to show is how the bottom-up approach has been incorporated into this approach.
- Craig spoke to the Special Consultative Procedure slide and covered the timing involved.



- It was noted that an update on the Strategy can be given at the Combined Tangata Whenua Forum 27 September, before the submissions start in October.
- Hearing Panel is Andrew Turner (Chair) John Scrimgeour, Bill Wasley, Paula Thompson,
 Matire Duncan. The Central Government Representative is still to be appointed.
- Possibly looking to add a climate change expert on the hearing panel to assist with any climate change issues raised.
- Whitiora noted the hearings are going to be different to normal and communication to the public needs to explain the process.
- There is a communications plan around the submission/consultations period. It is hoped to have as many people as possible knowing about this opportunity, knowing what it is and what it isn't, and they can come along to the hearing to talk to their submission.
- For the hearings to be useful, they need to be accessible, well understood, and welcoming.
- Whitiora noted communication and engagement is the biggest learning he has. Engagement
 work needs to have sufficient funding to make sure there is engagement within the
 community.

Claudia has joined to answer questions around water availability.

- Do we have a significant water supply for our growing population? What research is being done?
 - A working group has been formed, with TCC, BOPRC, WBOPDC to investigate how much water is available in the region. A report is coming out from this group, the report is currently being finalised and shows there is generally enough water. The report can be shared with CTWF once finalised.
- Moving forward while there may be enough water available, need to look at how it is distributed and what it means for the network.
- Our water future project will look into water supply, wastewater, and stormwater across the subregion. Hapu are being asked for their membership, working with Western Bay for the initial data. The goal is to line up with UFTI & SmartGrowth aspirations to confirm water supply/service in the various growth areas.
- Whitiora noted it is yet to be confirmed there is enough water and therefore requested the
 documentation to show there is enough water. Under the National Policy Statement, it
 doesn't show where the source of our water is coming from.
- If the water is being taken from a river and it is determined the source of the river, this could be a puna (underground water).
- Claudia noted it is understood the rivers that are used to supply drinking water are being fed
 by ground water reservoirs. In addition to the initial study a freshwater management tool
 has been developed, looking at the interaction from groundwater and surface water, this
 information will be used to underpin our assessment into how much water is available and
 how much we can take.
- Whitiora noted from his understanding there is no engineering that can adequately
 determine how big the basin is from where the three rivers come out and how much water
 is in there.
- Awareness of knowledge gaps, however based on the information available and looking at the ground water table, the interaction with the stream and ground water level over the long term of the last 50 years, it can be replicated.



- Claudia noted if this is the level of detail that is being looked at, a session can be looked at to talk through the details and information.
- It was asked if there is any way to look at the water situation in relation to the SmartGrowth Strategy looking at 50 years, 30 years, 10 years, 3 years. This will then help with our planning on what growth can look like in the subregion. Claudia noted through Our Water Future project it is planned to look at 100 year & 50 year horizon. TCC develop a 30 year horizon and 10 year/ 3 years.
- It was noted that the use per person is coming down with new devices and water efficient appliances. It also needs to be looked at if more buildings are high density then in turn less water will be used outdoors watering gardens.
- Elva thanked Claudia for her time and asked if the report mentioned could be presented at the next CTWF hui, Claudia agreed.

Māori housing.

- Te Pio talked to the Māori housing part of the presentation.
- Noting there is limited Whenua in both councils. Identified on the Map showing our 37
 Marae and lands that are within the councils and lands identified for housing. A lot of the
 lands identified for housing are zoned rural.
- This is a CTWF lead process, being included in the Transformation shifts aims to have papakāinga identified as a priority development area.
- For the future development strategy using the existing structure of 3 subregional Marae & Māori catchments.
- For the consultation, members encouraged not to wait till October, start putting the Strategy on the agenda for your forums now to discuss.
- Māori housing catchments
 - Te Kāhui Mana o Tauranga Moana (Western area of WBOPDC) includes 16 Trusts & 12
 Marae
 - Te Ihu o Te Waka o Te Arawa (Eastern area of WBOPDC) includes 14 Trusts & 12 Marae
 - Te Rāngapū Mana Whenua o Tauranga Moana (Tauranga City) includes 27 Trusts & 11
 Marae
- In working with the individuals, TCC, WBOPDC, all the reports, hui and the survey that Elva & Te Pio first did, all the information from these have been captured and included in our Future Development Strategy.
- Ara Rau Tāngata a WBOP Māori entity that represents and empowers Marae and Māori Land Trusts. Giving them the opportunity to work with crown agencies.
- Looking at a multi-year investment into Māori housing, as in line with the Strategy. Looking at the 11 Trusts to build their aspirations of 227. If in the first 3 years 50% of the aspirations could be achieved, it would be 128 houses being built.
- The figures included in the table doesn't include the WBOPDC, better-off funding already granted and other funding already agreed. This is a snapshot of our requirements to be shared with Ministers.
- Asking the Minister for at least \$30 million for infrastructure, notice in 3 years at least \$70 million in terms of funding support for housing on papakāinga.
- Constraints include their capacity in Tauranga to deliver the 128 houses. Working with Priority One on how we address these issues.



- The Chair congratulated Te Pio and the team and thanked them for the work done. Setting the groundwork from bottom up to now looking at the 50 year strategy.
- Work needs to be done on how Tangata Whenua and the SmartGrowth Strategy work together, looking at the methodology that Tangata Whenua use and how that fits into SmartGrowth.
- Looking at if or when Government changes, how we pick up and carry on.
- Craig noted Māori housing as a priority development area is the language Central Government uses, it's important to use this as a tool and include as part of a strategy to show unity.

Claudia was asked if the water report mentioned could be presented at the next CTWF hui,
 Claudia agreed.

- 9. Waka Kotahi Business Case for Tauriko SH29 Network (Paper D) - Presentation has been uploaded to the CTWF meetings webpage.
 - Kaylene spoke to the Waka Kotahi Business Case for Tauriko SH26 Network presentation.
 - Engagement has been primarily through the Te Kauae a Roopu Forum.
 - Aiming for realignment and naturalisation of the Kopurererua stream.
 - Developing a long term solution for SH29 & 29A. Staging process is required to support the development and manage the investment from the government.
 - Kaylene spoke to each stage covered in the presentation.
 - In the business case an adaptive management approach has been put in place, monitoring
 mechanisation over the network is happening, this will enable response if development is
 moving faster or slower and give availability to move depending on what is happening on the
 ground.
 - Seek endorsement from the Waka Kotahi board next month. Then will go into NLTP prioritisation process for funding the next stages. Currently only funded to complete the business case.
 - Kaylene spoke to the Phases for enabling works as shown in the presentation.
 - The Chair opened the floor to members for questions or comments.
 - No comments or concerns were raised by CTWF members in relation to the proposal.
 - Matire gave thanks for the presentation as this helps to understand the details.
- 10. Transpower and PowerCo - Presentation has been uploaded to the CTWF meetings webpage.



Matire introduced Transpower and PowerCo representatives to provide an overview of the current issues and planning around the region.

- The region's growing demand for electricity is putting unsustainable pressures on the network, major upgrades will be needed to ensure sufficient power and supply.
- Transpower and PowerCo are working together on options to support the region's electricity needs.
- Requesting input from Tangata Whenua, advice and feedback. To contribute to the current
 consultation by submitting thoughts concerns and questions relating to the regional
 electricity infrastructure, including Māori housing with detailed issues and solutions.
- The Transpower & Power Co representative introduced themselves. Tania Lund (Transpower), Neville Goodwin (PowerCo), Angela Pointon (Consultant), Cynthia Turuwhenua (PowerCo)
- Transpower transmits, PowerCo is the Distributor.
- Transpower has two key roles, National Grid owner and System Operator.
- PowerCo owns and operates local line distribution network and connects to Transpower's National grid.
- Some forecasts show that by 2050 there could be more than 100% electricity required than what is available in this region.
- PowerCo and Transpower are developing a strategy for the Western Bay of Plenty region shorter term to 2030 and longer term to 2050.
- The capacity to get the power to the region is good, the issue is getting it around the region as assets are in heavily urbanised areas.
- PowerCo connects to Transpowers substations, PowerCo has networks of smaller substations.
- Tania spoke to the Western Bay of Plenty Regional peak demand graph. The key points are:
 - The original forecast underestimated the electricity growth.
 - A forecast has been done looking at fully unconstrained electricity use (everything moves to EV) and then constrained use (very little EV use).
 - The new forecast was agreed based on research done to be the base load increase.
- Key challenges are constrained urbanised areas, consents and environmental approvals, land access to locate new assets and funding process.
- Requesting to open the lines of communication and start the dialogue. Keen to hear goals, aspirations and concerns. Long list consultation is live now, including a range of options and scenarios for the work needed.
- The Consultation closes 13 September.
- The Chair opened the floor to members for questions or comments.
- Te Pio thanked presenters.
 - o Tangata Whenua have limited land in urban centres, the majority of land sits in rural areas. How do we ensure power is sourced in rural areas without only relying on solar.
 - Most of PowerCo network is remote rural. To help the rural communities, looking to promote rural community resilience, taking advantage of new technology with solar and storage. Looking at community hubs and beefing up security and supply to those areas.



- Marae are our social centres, community hubs supported by the network of Māori Land Trusts. Looking to ensure those Marae/ social centres are the local face, including Health providers making sure we have house supply and local facility.
- Papakāinga model is ideal for what PowerCo is trying to achieve with community sharing. Putting in solar and battery storage is more economical if it can be shared.
- It was asked does Transpower & PowerCo retrofit more environmentally sustainable options. PowerCo is focusing on substations as they contain a lot of concrete looking at new build options and looking at options for power poles. Transpower has commissioned their first wood substation as opposed to concrete.
- Geoff enquired about the chain from where this power starts and who might own it before
 its distributed. A lot of Māori land are starting to come due; a lot of land will be coming back.
 The relationship that is being looked at now is very important but needs to be on a different
 level, looking at equity assets. It would be good to start meeting with Te Pio, Elva and others
 about the long-term connection, sharing and what comes out at the other end.
- The Chair acknowledged presenters and requested Transpower & PowerCo come back to present on the work that is being done for Papakāinga developments in the rural areas, particularly with the use of solar?

The EPPP will be implemented via Freshwater Management Units (FMU).


Progress on technical work relating to water quality and quantity

Technical work has been undertaken to assist in identifying issues,

management options and limits relating to freshwater health of these FMU's.

Outcome of recent engagement

The first round of Hui-ā-rohe were held in May 2023. For Mauao, 26 participants attended out of 38 who had pre-registered. Hui were also held in Ōkurei (Rotorua) and Kōhī (Whakatāne).

These hui were effective means to communicate to tāngata whenua on the NPSFM, our progress towards implementation including the critical opportunities that lie within Te Mana o te Wai, the mahinga kai compulsory value and work towards a responsive RNRP. The hui also highlighted the tangible opportunities for tāngata whenua and kaitiaki to help inform regional freshwater decision making.

Attendees particularly enjoyed the iwi presentations:

- Ngāti Rangiwewehi presented at the Ōkurei hui ā rohe in Rotorua.
- John Rapana from Ngati Makino presented at the Kōhī hui ā rohe.
- Pia Bennett presented the Tauranga Moana project at the Mauao hui ā rohe.

These presentations provided a good understanding of how some iwi have approached this kaupapa. The presentations were a valuable catalyst that has generated additional interest from tāngata whenua about how they could potentially participate.

The audience at these hui-ā-rohe are at varying stages of their 'wai Māori' journey and the kōrero reflected that. There were some robust discussions about allocation, the draft FMUs and the current state of the health of freshwater, water bodies and the surrounding environment.

Staff are currently planning a round of targeted engagement with iwi, hapū and tāngata whenua to be held in September. Staff maintain an open invitation to iwi, hapū and tāngata whenua to engage with us, when they are ready to do so. Where there are requests for further engagement, these requests have been and will continue to be followed up by staff.

ITEM 9: UPDATE FROM TĀNGATA WHENUA REPS ON SMARTGROWTH LEADERSHIP GROUP

Tāngata whenua representatives on the SmartGrowth Leadership Group (SLG) will provide a verbal update on key activities since the last CTWF meeting.

This includes:

- 1 August online hui with Minister Megan Woods and the Ministry of Housing and Urban Development.
- 18 August informal SLG workshop to go through the draft SmartGrowth Strategy.
- 13 September SLG meeting which included approval to release draft Strategy for consultation.
