Item 5 - Guest presentation – Iwi led planning: Maketu Climate Adaptation Plan

Roanna Bennett presented to the Forum He Toka Tu Moana (Maketu Climate Adaptation Plan):

- Plan developed by collaboration of Maketu Iwi (Te R<u>ūnanga</u> o Ngāti Whakaue ki Maketu, Whakaue Marae Trustees and Ngāti Pikiao Noho ki Tai)
- The coastline of Maketu is already impacted by climate change and it's difficult to predict and influence what is going to occur.
- The Marae will be affected, discussion of a potential relocation has started.
- The collective approach to Climate Change Adaptation in Maketu developed by Te Arawa Iwi, involved the Maketu community. Five workshops held in total including Climate Change 101 was held, where they wrote down all info they have in terms of present and future impacts of Climate Change in the area.
- Roanna explained to the group the set values, vision, 5 strategic priorities, 12 projects, and 7 enabling actions that came out of these meetings.
- The focus is only internal at the moment not open to circulate with the community yet.
- The approach of this plan is collaborative, there's no owner and there are no obligations to assist.
- TCC is also working on a Climate Plan internally.

ACTION: Presentation to be distributed.

Item 6 - SmartGrowth SLG 17 August update

- Decision was made around SmartGrowth Forums: only CTWF will maintain the same format, Developers Forum will continue in a different form and the others will get disestablished.
- Each council will lead their own stakeholder engagement for projects related to SmartGrowth.
- Opportunity for this group to have a stronger say at the decision table.
- Discussions around Peter Winder's departure. Anne Tolley to be the new interim Chair.
- Debates around the 22M available funding on Three Waters as well as in WBOPDC. The group agrees on submitting to it, and the need to influence the right people to seek a good allocation on the funding.
- Uncertainty as to whether CTWF should apply to the funding directly or through council (dependent if its project based or not).

ACTION: To have Eastern Corridor Development as an item for the next hui.

Item 7 - CTWF priority projects – Paper C

- Māori housing aspirations discussed.
- Kainga Ora here to present followed from last hui with MHUD (Ministry of Housing and Urban Development).



- The group discussed the need for people able to influence housing in Māori land to present at CTWF hui.
- Progressing with working group on Māori land forming an entity, which will give opportunity to restructure and reform.
- 45-50 people participated in the Māori Land Forum, currently 14 land trusts that already progressed to the concept planned, and some are already building.
- Councils still need to respond to what the actual capacity is for building. It's imperative to increase the actual capacity, which is quite low at the moment.
- Contrast to what happens in the developer's space as opposed to individual Māori Land Trusts, since it's hard to find recourse to produce the development plans required for them.
- Priority for SG is addressing the 7 PDAs (now including Eastern Town).
- Elva noted the development of a report card to provide regular updates to CTWF about their priority projects and actions for the year. She also mentioned that no applications have been received for the SmartGrowth Tū Pakari Pou Hononga role, so a range of different approached will be needed to the way we engage for the housing and spatial planning work.
- WBOPDC has provided some support in terms of a secondment (Julie Shepherd) to provide research and engagement support as well as the bringing in specialist contractors short-term to help with engagement.

Item 8 - Tangata Whenua Spatial Planning Overview: Arthur Flintoff

- Arthur provided an overview about spatial planning, including legislative context and purpose.
- Chair thanked for the presentation and invited him to stay on board.
- Whitiora noted that he had made a submission on developer contributions to get the funding. He considered it to be positive to have our own CTWF spatial plan.
- Matire had some concerns around the suggested budget amount, as she considered it not sufficient if split into 3 years.
- Discussions around the statutory authority, and who's responsible for the SP. Matemoana noted there isn't one at this stage, until the new Strategic Planning Act is in place.
- It was noted the CTWF needed its own generic spatial plan and a project coordinator was needed for this job. Arthur also needed to be actively involved.

ACTION: Presentation to be distributed.

Item 9 - Māori Land Court – Māori landowners – Whenua use and development readiness

- Maria Graham from Te Kooti Whenua Māori presented to the group.
- Discussions around the capacity for the Māori Trust to manage the current challenge and how long they take to get processed. Maria responded that if all is in order, the applications should get processed within 8 weeks.
- Discussions around Whenua use and development readiness, features of Māori Freehold Land and General Land owned by Māori.
- Trustee training 2022 online sessions 2 streams: by Hamilton Registry and by National Office and discussions around optimising community engagement.
- Maria requested to contact her and her team with any queries.

ACTION: Presentation to be distributed



Item 10 - Kāinga Ora - Strategic overview and update on local projects

Manu Graham from the Rautaki Team of Kāinga Ora provided a verbal update to the Forum:

- His team is working on Funding & investment and building capability.
- Environment plan is due in 6 months.
- Manu requested to contact him and his team with any specific queries.
- The Forum expressed their concern around lack of resources applied to housing, as well as lack of urban development from Māori perspective. The group noted the Importance to start looking at the Māori housing aspirations.
- Matemoana requested Manu to please make the decisions needed to start building. She also suggested, when inviting Kāinga Ora or guest presenters in the future that we do so through a workshop instead, since this way the flow of the formal meetings gets altered.

Campbell Larking from Kainga Ora presented on Tauriko West – Ferncliffe Farms:

- SmartGrowth project since 2016
- TCC & Waka Kotahi working together to build the state highway.
- Discussions around the stated approach, development plan, the protection of the river and road access in the area.
- The forum expressed their concern around keeping the developers out of purchasing land first to keep the price from increasing even more.

### WHAT I WANT TO TALK TO THE CTWF ABOUT

Provide members with an overview of the Transport System Plan (TSP), our draft partnering and engagement strategy, and the linkage to spatial planning.

## WHY I WANT TO TALK TO THE CTWF ABOUT THIS

Ensure TSP mana whenua partnering and engagement is joined up and mana whenua priorities impacting decision making are integrated into the broader spatial planning and project delivery.

Historically, iwi/hapu involvement has been too late into transport projects and at too shallow a level. This is now changing. TSP has established a Working Group to explore how best to frame up effective and meaningful partnering an engagement. This is starting to bear fruit with more co-ordination happening with sub-regional Spatial Planning (through the JSP refresh) and consistency in Project Delivery, but there is further to go.

Regarding Spatial Planning, TSP strategic engagement with mana whenua is closely linked to the spatial planning work. Generally, the transport system is a consequence of integrated landuse and transport planning, therefore we are wanting strategic engagement to come through/ be linked up with the JSP refresh and Iwi Spatial Plan.

We are working closely with the team undertaking the JSP so that any conversations with mana whenua are joined up and any priorities that impact on transport planning decision making are captured in the broader spatial planning context.

Regarding Project Delivery, there are two levels at which project partnership and engagement can primarily occur. They are:

- Governance (Project Steering Group)
- Working (Project Team)

There are numerous TSP projects bay wide, and everyone is trying to engage with hapū separately. The TSP wants to have a co-designed framework that can be tailored to each situation (noting there are different levels of engagement and governance), to ensure we engage at the right time with the right information.

Hapu resourcing is the other critical constraint that the Working Group is considering. Currently, representation is stronger at a governance level than at the working/project team level. It is recognised there is need for greater Māori representation the project team/technical level for at Māori engagement/partnership to be more effective. A result of this is that it often puts Tangata Whenua into unfamiliar positions, where they do not have the capability or capacity to perform and look after their interests to the best ability. We are looking at a different way to address capability and capacity to provide for better project outcomes (for both maori and the general public).

## WHAT I WANT FROM THE CTWF

- 1. Raise CTWF members understanding of the TSP, its draft partnering and engagement strategy, and how can mana whenua influence TSP decision-making and spatial planning.
- 2. Support for development of a TSP Mana Whenua Engagement framework.

# Subject: Subregional Waters Servicing Study: Tangata Whenua engagement and partnering

#### WHAT I WANT TO TALK TO THE CTWF ABOUT

- A joint programme between TCC and WBOPDC to co-develop an overall waters servicing strategy that addresses long-term needs of Tauranga and the Western Bay sub-region.
- No prior engagement with tangata whenua has been initiated to date. However, there was a high level of interest in such a project when the idea of a more holistic integrated study was flagged at a Te Rangapu Moana Partnership meeting and at a Waiari Kaitiaki Group meeting.

#### WHY I WANT TO TALK TO THE CTWF ABOUT THIS

• To seek their advice as to how engagement with Tangata Whenua may be undertaken and resourced to partner in the programme.

(Why talking to the CTWF about this topic is important is, decision-making processes and timeframes are outlined below).

- The purpose of an overall waters servicing strategy is to addresses long-term needs of Tauranga and the Western Bay sub-region giving effect to Te Mana o Te Wai and the National Policy Statement Freshwater Management.
- The strategy will inform investments, plans and policy decisions required concerning water services to support planned growth in the sub-region according to UFTI growth assumptions.
- Significant engagement is anticipated to be required with iwi/hapu representatives to find ways to resource cultural input and participation in processes for elaborating a waters servicing strategy.
- There is synergy between the Joint Spatial Plan work being undertaken by CTWF for SmartGrowth and work anticipated under this programme.

#### **Decision-making processes**

(To be addressed in presentation)

- Tangata Whenua involvement (TBC subject of this meeting)
- The high-level process proposed requires nominating representatives from TCC, WBOPDC and tangata whenua to a working group and a programme governance group.
- These groups will determine scope of required studies and methods to evaluate alternatives with assistance from relevant experts from TCC's supplier panel for three waters planning
- TCC's supplier panel for three waters planning will provide technical advice to the working groups and deliver the programme outputs. Where required, open tender processes will be used to deliver the overall strategy and supporting technical studies.
- A TCC programme manager will coordinate interactions between these, tangata whenua, SmartGrowth and suppliers.

#### <u>Timeframe</u>

Stage 0 – Problem definition and scoping study	2022
Stage 1 – Project Setup and Baseline assessment/stock take	late 2022
Stage 2 – Options development	early 2023
Stage 3 – Options assessment	late 2023
Stage 4 – Strategy documentation	2024

Parts of Stage 1 are already underway through other current projects, especially for water supply. Existing information will be utilised and built on for identifying long-term solutions.

- Advice on the engaging with and reporting to this combined forum
